
# PowerShares US High Yield Fallen Angels UCITS ETF (the "Fund") A sub-fund of PowerShares Global Funds Ireland plc (the "Umbrella Fund") Class CHF hedged accumulation (ISIN: IE00BYVTMY13) (the "Share Class")

The Fund is managed by Invesco Global Asset Management DAC, part of the Invesco Group.

# Objectives and Investment Policy

- The Fund is an Exchange Traded Fund. This means shares in the Fund are listed and traded on one or more stock exchange(s).
- The objective of the Fund is to generate income, together with capital growth which would, before expenses, correspond to, or track, the return on the Citi Time-Weighted US Fallen Angel Bond Select Index (the "Index") by investing in a representative sample of the constituents of the Index.
- An index measures the performance of a selection of securities representative of the overall market or a subsection of it.
- To achieve the objective the Fund will, as far as practicable, hold a sample of components of the Index.
- The Index measures the performance of US\$ "fallen angels" i.e., US\$ corporate bonds which were (i) previously rated investment-grade (higher quality) and subsequently downgraded to high-yield (lower quality); or (ii) previously rated high-yield, subsequently rated investment-grade and then downgraded again to high-yield.
- The Index is based on the Citi Time-Weighted US Fallen Angel Bond Index which includes US Dollar-denominated bonds issued by corporations domiciled in the US or Canada.
- You can buy and sell shares in the Fund on any Business Day (as defined in the Prospectus).
- Any income from your investment will be reinvested.

# Risk and Reward Profile



- The Share Class is in risk category 4 due to the rises and falls of its price or simulated data in the past.
- As the Share Class' risk category has been calculated using historical data, it may not be a reliable indication of the Share Class' future risk profile.

### Other Risks

- The value of investments, and income from them, can go down as well as up and you may not get back the full amount you invested.
- Although the Investment Manager will continually monitor the return of the Fund in comparison to the performance of the relevant Index, there can be no guarantee that the Fund will match the performance of the Index.
- The Fund's use of a sampling approach may result in it holding a smaller number of securities than are in the Index. This may affect its ability to track the Index and may result in larger fluctuations in its value than if it held all of the securities in the Index.
- In tracking the Index, the Fund will be concentrated in a single country or a small number of countries. Investors should be prepared to accept a higher degree of risk than for a fund that is geographically diversified.
- Changes in interest rates will result in fluctuations in the value of the Fund.
- Debt securities are exposed to credit risk which is the ability of the borrower to repay the interest and capital on the redemption date.
- The Fund will hold a large amount of debt securities which are of lower credit quality and may result in large fluctuations in the value of the Fund.
- This Share Class is denominated in a different currency than that of the base currency of the Fund and may be hedged to mitigate against the effect of exchange rate fluctuations between the two currencies. However, this may not be achieved.
- The Fund will hold a large amount of lower quality debt securities which may impact the liquidity of the Fund under certain circumstances.
- As the shares of the Fund are listed on one or more stock exchange(s) there may be insufficient demand to buy or sell the shares which may cause the price to be different than the actual value of the net asset value of the Fund.
- Return on your investment may be adversely affected by variations in exchange rates.

As a result of the introduction of a material change in the fee paid to the Manager, the ongoing charges figure reflects the expected total of charges.
- It excludes portfolio transaction costs except in the case of an entry or exit charge paid by the Fund when buying or selling shares/units in another fund.
