The Investment Manager will actively manage the Fund, seeking to achieve the objective by providing long and short exposure in an unconstrained manner, either directly or via derivatives, to a broad range of fixed income securities and strategies across multiple regions, including securities with both investment-grade and non-investment-grade credit ratings. There is no guarantee that the return objective will be achieved, and capital is at risk. 

#### WHAT ARE THE RISKS?


