The Company is managed by PGIM Investments (Ireland) Limited, part of the PGIM group of companies.

Objectives and Investment Policy

The Fund aims to outperform ICE BofA US 3-Month Treasury Bill Index (the "Benchmark") over a full market cycle on a total return basis. There can be no assurance that the investment objective will be achieved.

The Fund will be actively managed and will seek to add value through investing in a variety of debt securities and instruments. The Benchmark will be used for performance comparison purposes only.

The Fund's investments may include debt issued by any sovereign, agency, governmentsponsored entity, supra-national, or municipal or corporate issuer, asset-backed securities, commercial mortgage-backed securities, residential mortgage-backed securities, Rule 144A securities, certain loan instruments, trust preferred securities, preferred stock, and private placement securities, all of which are subject to certain limits as set out in the Fund's Supplement.

The Fund's investments may be issued by either US or non-US issuers. These investments may be fixed or floating rate in nature, and may be US dollar or non-US dollar denominated.

The Fund may also use to a significant extent, for investment, risk management or hedging purposes, exchange-traded and over-the counter derivatives including futures and options, credit default swaps, forward contracts, total return swaps, and interest rate swaps, currency swaps and swap options (swaptions), the underlying reference assets for which will be bonds, in which the Fund may invest directly, interest rates, indices and currencies. The Fund may also engage in efficient portfolio management techniques.

The Fund may not be leveraged in excess of 1500% of its net asset value, through the use of derivatives.

The Investment Manager has determined that the Fund promotes sustainability characteristics, due to its use of its internal evaluation process, which analyses securities based on ESG criteria established by PGIM Fixed Income's ESG committee, and is therefore classified under Article 8 of the Sustainable Finance Disclosure Regulation ("SFDR"). The Fund seeks to avoid investing in issuers that engage in activities that are not in compliance with certain socially-responsible investment criteria set forth by the ESG committee. Although the Fund promotes sustainability characteristics, it does not have sustainable investment as its investment objective.

It is not currently anticipated that dividends will be declared in respect of the Class. Net investment income attributable to the Class is expected to be retained by the Fund, which will increase the net asset value per share of the Class.

Portfolio transaction costs, which are paid by the Fund in addition to the costs set out under "Charges" below, may have a material impact on the performance of the Fund.

Investors can buy and sell their shares on each business day of the Fund.

The Fund may not be appropriate for investors who plan to sell their shares within the short term

The shares are denominated in US Dollars. The base currency of the Fund is the US Dollar.

The Fund's risk category of 4 has been calculated using simulated historical data which may not be a reliable indicator of the Fund's future risk profile.

The risk rating of the Fund is calculated using a standard methodology used by all UCITS funds, and shows where the Fund ranks in terms of its relative risk and potential return based on past share price fluctuation. Below are certain risks that you should be aware of that may result in a loss or reduction in the value of your investments. These risks are not exhaustive. Potential investors should consult the prospectus and their professional advisers before investing in the Fund.

Bank Loans Risk: The Fund's ability to receive payments of principal and interest and other amounts in connection with loans (whether through participations, assignments or otherwise) will depend primarily on the financial condition of the borrower. The failure by the Fund to receive scheduled interest or principal payments on a loan because of a default, bankruptcy or any other reason may adversely affect the income of the Fund and reduce the value of its assets.

Call Risk: If an issuer exercises its right to redeem a security prior to its maturity (a call), the Fund may not recoup the full amount of its initial investment and may be forced to re-invest in lower-yielding securities, securities with greater credit risks or with other less favourable features

Counterparty Risk: Risk of material investment exposure through contracts with a third party

Credit Risk: The value of debt securities may be adversely impacted by the erosion in the ability of the issuer to pay the amounts of interest and principal owed as they become due.

Emerging Market Risk: The Fund invests in emerging markets, which may experience political, market, social, regulatory, and/or economic instabilities. These instabilities may reduce the value of the Fund's investments.

Securitised Product Risk: Securitised products may be less liquid than other debt securities, may be prone to substantial price volatility and are subject to issuer repayment, counterparty and credit risk. Securitised products carry certain additional risks which may adversely impact the return on the securities, including: the possibility that distributions from collateral securities will not be adequate to make interest or other payments; the quality of the collateral may decline in value or default; and the possibility that the securitised products are subordinate to other classes.

Sovereign Debt Risk: Sovereign debt risk is the risk that the governmental entity that controls the repayment of sovereign debt may not be able or willing to repay the principal and/or interest when due in accordance with the terms of such debt, due to factors related to its cash flow, its foreign reserves and political constraints, among others. If a governmental entity defaults, there may be few or no effective legal remedies for collecting on such debt.

Socially Responsible Investment Risk: The Fund may achieve lower returns than an equivalent fund which does not pursue a socially responsible mandate.

The charges you pay are used to pay the costs of the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.


