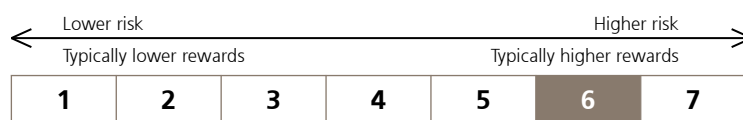

- The exchange rate risk between USD and EUR is largely hedged.

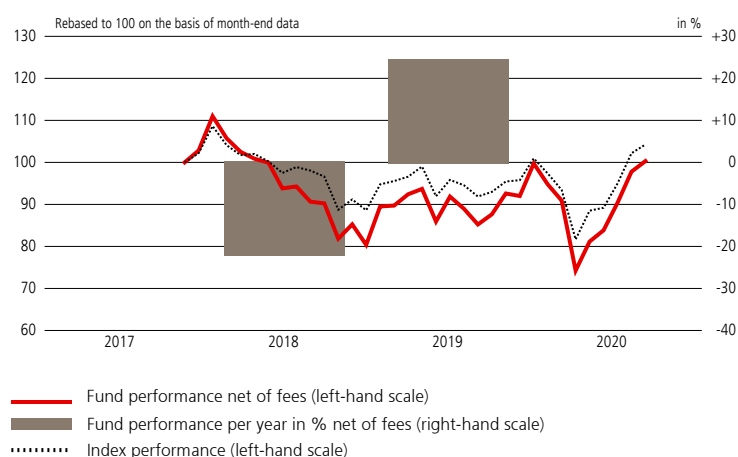
