UBAM is managed by UBP Asset Management (Europe) S.A.

### Objectives and investment policy

The Fund seeks to grow your capital and generate income by investing primarily in growth-oriented US equities or equivalent.

The Fund is actively managed, investing at least 80% of its net assets in US companies with a minimum market capitalization of USD 1 billion and up to 20% of its net assets in non-US companies carrying a substantial part of their commercial activity in the US with a minimum market capitalization of USD 5 billion

The Fund focuses on long-term growth, with an emphasis on the sustainability and quality of that growth rather than shorter-term or cyclical events.

A performance fee in reference to the S&P 500 Index (the "Benchmark") is applied to some share classes. The Benchmark is not representative of the risk profile of the Fund. The performance of the Fund is likely to be significantly different from that of the Benchmark because the Investment Manager has significant discretion to deviate from its securities and weighting.

The Fund's base currency is USD.

As an equity fund, its holdings can move in line with or return less than the broad stock market, so investors should be aware that the value of their holdings could fall and that they may not get back their initial investment.


Any income received by the Fund is reinvested (capitalisation share class).

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg except days where the decisive market is closed: United States (US).


