

It combines our best investment and highest conviction ideas across ten Asia ex-Japan markets. The team makes use of a bottom-up, selective approach to invest in companies that display sustainable leadership and competitive advantages, with reference to the macroeconomic market environment. We like companies that are trading at a discount to our estimation of fair value. Environmental, Social and Governance (ESG) considerations are fully integrated in the investment process.




