## Objectives and investment policy

The Fund seeks to grow capital and generate income by investing primarily in Emerging countries corporate bonds.

The Fund is actively managed and invests in bonds with a minimum rating of B- (S&P or Fitch), B3 (Moody's) or an equivalent rating by another rating agency. As an exception to this rule, the Fund may invest up to 15% of its net assets in products/issuers with a lower rating and up to 15% in non-rated products/issuers.

The Fund invests mainly in currencies of OECD countries. The currency risk against USD will be largely hedged.

The investment strategy relies on credit and macroeconomic assessment, Environmental, Social and Governance (ESG) analysis as well as on relative

The sustainable objectives of the Fund are to provide:

- a lower carbon footprint than its investment universe, as measured by the JP Morgan Corporate EMBI Diversified Index ("the Benchmark")
- a higher ESG Quality Score than its Benchmark as measured using the MSČI ESG research.

The investment process includes a first phase of investment universe filtering and a second phase of ESG bottom-up research.

The first phase consists in selecting issuers with sound ESG quality and avoids controversial business activities as well as companies in breach of international norms (norms-based screening).

Selected issuers have to carry an ESG rating from MSCI ESG research with a minimum of BB. As an exception of this rule, up to 10% of the net assets can be invested in non-rated bonds.

The second phase integrates ESG considerations into the issuers' qualitative credit assessment conducted by the Investment Manager. This analysis relies on different sources of information and data as well as external ESG data and scoring providers.
The ESG analysis covers at least 90% of the Fund's portfolio.

The Fund uses the Benchmark for performance objective. The Benchmark is not representative of the risk profile of the Fund and the performance of the Fund is likely to be significantly different from that of the Benchmark because the Investment Manager has significant discretion to deviate from its securities and weighting.

The Benchmark is not aligned with the environmental and/or social characteristics promoted by the Fund.

The Fund may invest its net assets up to:

- 100% in High yield
- 100% in Emerging countries. This exposure can be increased up to 120% through derivatives
- 20% in Contingent Convertible bonds (CoCos).

High yield bonds are issued by entities whose activity is more sensitive to the economic cycle and pay higher interest. The return on such securities, in the same way as their level of risk, is therefore higher than traditional bond products.


The Fund's base currency is USD.

Any income received by the Fund is reinvested (capitalisation share class). Investors in the Fund can subscribe and redeem units on any business day in Luxemboura.

# Risk and reward profile

Significant risk(s) for the Fund not taken into account in this indicator include the following:

Counterparty risk: The use of over-the-counter derivatives exposes the Fund to a risk that the counterparty to the transactions will fully or partially fail to honour its contractual obligations. This may result in a financial loss for the Credit risk: The Fund invests in bonds, cash or other money market instruments. There is a risk that the issuer may default. The likelihood of this happening will depend on the credit-worthiness of the issuer. The risk of default is usually greatest with bonds that are rated as sub-investment grade.

Currency risk: The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

Emerging countries risk: The Fund invests in overseas countries which carry a higher risk than investing in larger established countries. Investments in Emerging countries are likely to experience greater rises and falls in value and may suffer trading problems. A Fund which invests in Emerging countries rather than more developed countries may encounter difficulties when buying and selling investments. Emerging countries are also more likely to experience political uncertainty and investments held in these countries may not have the same protection as those held in more developed countries.

ESG and Sustainability risk: It may result in a material negative impact on the value of an investment and performance of the Fund. Assessment of sustainability risks is complex and requires subjective judgments, which may be based on data which is difficult to obtain and/or incomplete, estimated, out of date or otherwise materially inaccurate. All or part of said data may come/originate from third parties.

Liquidity risk: Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to trade at advantageous times or prices.

### Charges


