FUND OVERVIEW

The Fund aims to maximise the return on your investment through a combination of capital growth and income on the Fund's assets. The Fund invests at least 70% of its total assets in the equity securities (e.g. shares) of companies domiciled in, or the main business of which is in, the People's Republic of China. The Fund will have a flexible allocation between onshore and offshore Chinese equity markets.





#### SUSTAINABILITY CHARACTERISTICS
