The Wellington Opportunistic Fixed Income Fund seeks to generate returns of 5% – 7% a year before the deduction of fees. The Investment Manager will actively manage the Fund, seeking to achieve the objective by providing long and short exposure in an unconstrained manner, either directly or via derivatives, to a broad range of fixed income securities and strategies across multiple regions, including securities with both investment-grade and non-investment-grade credit ratings. There is no guarantee that the return objective will be achieved, and capital is at risk. 

WHAT ARE THE RISKS?


