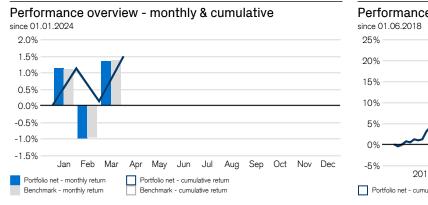

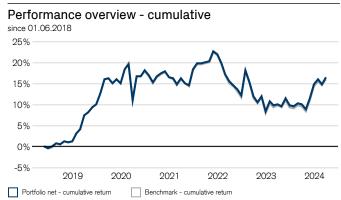
## **Investment Policy**

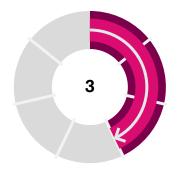
