To maximize total return through income generation and capital appreciation, consistent with prudent investment management.

INVESTMENT PROCESS

The fund is actively managed and Invests mainly in a diversified portfolio of transferable US dollar denominated fixed income securities of issuers domiciled, or exercising the predominant part of their economic activity, in Asian countries including emerging markets, excluding Japan. The fund may use derivatives for hedging and efficient portfolio management and will be consistent with the fund objectives and Environmental Sustainability characteristics of the fund.
