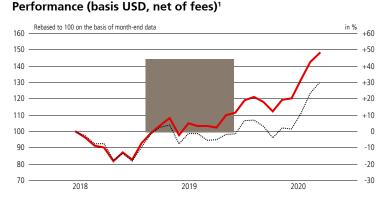
Fund description
