This fund is managed by Vontobel Asset Management S.A., which is part of Vontobel Group.

This fund is authorised in Luxembourg and regulated by the Commission de Surveillance du Secteur Financier (CSSF).

# Objectives and investment policy

This actively managed sub-fund aims to achieve sustained long-term capital growth in CHF, while accepting moderate volatility and moderate portfolio risk.

- The sub-fund may invest all of its net assets in interest-bearing securities, up to 65% in equities and equity-like securities and up to 30% in alternative investment instruments. Up to 20% of its net assets may be cumulatively invested in asset-backed and mortgage-backed securities, contingent convertible bonds (CoCo-Bonds) and distressed securities, with investments in the latter limited to 10% of the sub-fund's assets. Investments can also be made indirectly via derivative instruments, structured products or permitted investment funds. It may invests up to 49% in bank deposits at sight and money market instruments for liquidity management.
- The sub-fund invests mainly in securities issued by companies around the world. The sub-fund may also invest in instruments that

offer indirect participation in the performance of investments including real estate, precious metals, commodities and hedge funds. It may also hold cash up to 20% of its net assets.

- The sub-fund may use derivatives for hedging purposes.
- The portfolio manager has full investment discretion within the predefined investment limits.
- Any income generated will be reinvested and included in the value of your shares.
- Buying and selling securities entails transaction costs payable in addition to the charges listed.
- Redemption of shares: daily when banks in Luxembourg are open for normal business (see prospectus for details and exceptions).
- F shares are intended exclusively for investors who have signed at the time of subscription an agreement with a company in the Vontobel Group. The shares do not grant any rebates or retrocessions.

- Asset-backed and mortgage-backed securities and their underlying receivables are often non-transparent. The sub-fund may also be subject to a higher credit and/or prepayment risk.
- CoCo-Bonds may entail significant risks such as coupon cancellation risk, capital structure inversion risk, call extension risk.
- Distressed securities have a higher credit and liquidity risk as well as uncertainty in any potential bankruptcy proceedings.
- A company's stock price may be adversely affected by changes in the company, its industry or economic environment and prices can change quickly. Equities typically involve higher risks than bonds and money market instruments.


