#### **FUND OVERVIEW**

The Fund invests globally at least 70% of its total assets in fixed income securities. These include bonds and money market instruments (i.e. debt securities with short term maturities). In order to generate above average income, the Fund will seek diversified income sources across a variety of such fixed income transferable securities. The Fund's total assets will be invested in accordance with its ESG Policy as disclosed in the prospectus. 
