Objective and investment policy

The fund aims to provide a combination of capital growth and income to deliver a return that is higher than that of the global convertibles market over any five-year period while applying ESG Criteria.

Core investment: at least 70% of the fund is invested in convertibles issued by companies from anywhere in the world, including emerging markets. Exposure to these securities may be achieved, either directly or indirectly, through various combinations of corporate bonds, equities and derivatives. The fund also holds company shares in combination with bonds to replicate the exposure to convertibles when a direct holding is not available. Company shares are also held to adjust the technical characteristics of individual convertibles, such as making them more sensitive to changes in the price of the shares into which they convert. The Fund invests in securities that meet the ESG Criteria, applying an Exclusionary Approach and Positive ESG Tilt as described in the precontractual annex

Other investments: the fund may invest in other funds, contingent convertible debt securities and cash or assets that can be turned into cash quickly.

Derivatives: for investment purposes and to reduce risk and cost. **Strategy in brief:**

• Investment approach: the fund employs a disciplined approach to select each convertible. The strategy is based on the analysis of individual companies, and the characteristics of the bonds and shares of these companies. The fund manager seeks to identify convertibles that, in their opinion, provide the best risk-return profile. For these convertibles, the fund manager expects that the potential gain from the option on the underlying share price exceeds the potential loss

• Investment manager's ESG classification: Planet+ / ESG Enhanced, as defined in the fund's prospectus.

Benchmark: Refinitiv Global Focus Convertible Bond Index

The benchmark is a comparator against which the fund's performance can be measured. It is a net return index which includes dividends after the deduction of withholding taxes. The index has been chosen as the fund's benchmark as it best reflects the scope of the fund's investment policy. The benchmark is used solely to measure the fund's performance and does not constrain the fund's portfolio construction.

The fund is actively managed. The investment manager has complete freedom in choosing which investments to buy, hold and sell in the fund. The fund's holdings may deviate significantly from the benchmark's constituents.

For unhedged and currency hedged share classes, the benchmark is shown in the share class currency.

The main risks that could affect performance are set out below:

- The value and income from the fund's assets will go down as well as up. This will cause the value of your investment to fall as well as rise. There is no guarantee that the fund will achieve its objective and you may get back less than you originally invested.
- Convertibles are subject to the risks associated with both bonds and company shares, and to risks specific to the asset class. Their value may change significantly depending on economic and interest rate conditions, the creditworthiness of the issuer and the performance of the underlying company shares. In addition, issuers of convertibles may fail to meet payment obligations and their credit ratings may be downgraded. Convertibles may also be harder to sell than the underlying company shares.
- The fund may use derivatives to profit from an expected rise or fall in the value of an asset. Should the asset's value vary in an unexpected way, the fund will incur a loss. The fund's use of derivatives may be extensive and exceed the value of its assets (leverage). This has the effect of magnifying the size of losses and gains, resulting in greater fluctuations in the value of the fund.

- The fund could lose money if a counterparty with which it does business becomes unwilling or unable to repay money owed to the fund.
- Operational risks arising from errors in transactions, valuation, accounting, and financial reporting, among other things, may also affect the value of your investments.
- ESG information from third-party data providers may be incomplete, inaccurate or unavailable. There is a risk that the investment manager may incorrectly assess a security or issuer, resulting in the incorrect inclusion or exclusion of a security in the portfolio of the fund.
