Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long term capital growth by tracking as closely as possible the performance of the MSCI World Net Total Return Index (the Index).

Investment Policy:

The Index is comprised of the large and mid-sized companies (based on the market value of their shares, also known as market capitalisation) in developed markets, as defined by the Index provider.

The Fund is passively managed. The Fund utilises an investment technique called optimisation, which seeks to minimise the difference in return between the Fund and the Index by taking into account tracking error (the risk that the Fund return varies from the Index return) and trading costs when constructing a portfolio. The Fund invests in shares of companies.

The Fund will not necessarily invest in every company that comprises the Index, or invest proportionally to each company's weight in the Index.

If the overall portfolio matches the characteristics of the Index, the Fund may invest in companies outside the Index, but which are expected to provide similar performance and risk characteristics to certain Index constituents.

If the Fund cannot invest directly in the companies, it can may gain exposure by using other investments such as depositary receipts, derivatives or funds.

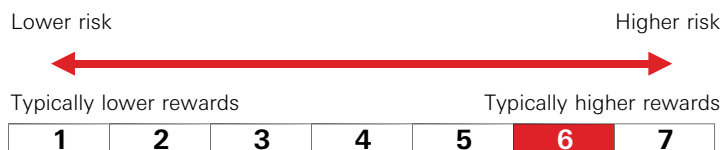
The Fund may invest up to 10% of its assets in other funds, including HSBC funds.

The Fund may also invest up to 10% of its assets in total return swaps. However, this exposure is not expected to exceed 5%.

The Fund may also invest in derivatives for hedging and efficient portfolio management purposes (such as to manage risk and costs, or to generate additional capital or income).

- ◆ The Fund may enter into securities lending transactions for up to 30% of its assets. However, this is not expected to exceed 25%.
- ◆ The reference currency of the Fund is USD. The reference currency of this share class is USD.
- ◆ Income is reinvested.
- ◆ You may sell your investment on most working days.
- ◆ Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

Material risks not fully captured by the Risk and Reward Indicator:

- ◆ **Counterparty Risk** The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.

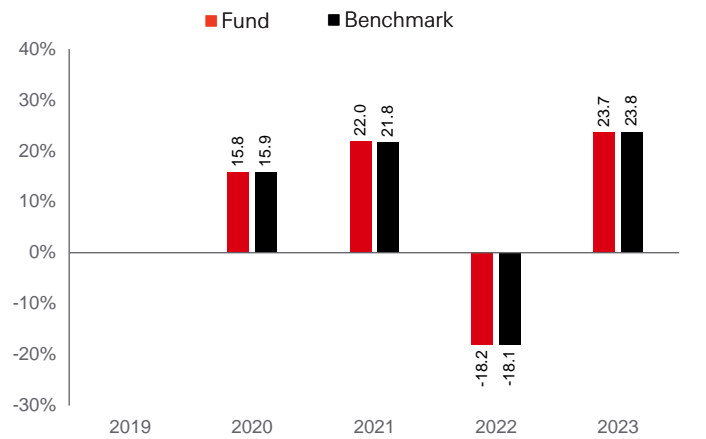
- ◆ **Derivatives Risk** Derivatives can behave unexpectedly. The pricing and volatility of many derivatives may diverge from strictly reflecting the pricing or volatility of their underlying reference(s), instrument or asset.
- ◆ **Exchange Rate Risk** Changes in currency exchange rates could reduce or increase investment gains or investment losses, in some cases significantly.
- ◆ **Index Tracking Risk** To the extent that the Fund seeks to replicate index performance by holding individual securities, there is no guarantee that its composition or performance will exactly match that of the target index at any given time ("tracking error").
- ◆ **Investment Leverage Risk** Investment Leverage occurs when the economic exposure is greater than the amount invested, such as when derivatives are used. A Fund that employs leverage may experience greater gains and/or losses due to the amplification effect from a movement in the price of the reference source.
- ◆ **Liquidity Risk** Liquidity Risk is the risk that a Fund may encounter difficulties meeting its obligations in respect of financial liabilities that are settled by delivering cash or other financial assets, thereby compromising existing or remaining investors.
- ◆ **Operational Risk** Operational risks may subject the Fund to errors affecting transactions, valuation, accounting, and financial reporting, among other things.

Charges
