| <div>Objectives</div> <div>The fund aims to provide capital growth in excess of the MSCI Emerging Markets (Net TR) Index after fees have been deducted over a three to five year period by investing in equities of emerging markets companies.</div> <div>Investment policy</div> <div>The fund is actively managed and invests at least two-thirds of its assets in equities of companies in emerging markets.</div> <div>The fund may invest directly in China B-Shares and China H-Shares and may invest less than 20% of its assets (on a net basis) directly or indirectly (for example via participatory notes) in China A-Shares through Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect and shares listed on the Science Technology and Innovation (STAR) Board and the ChiNext.</div> <div>The fund may also invest up to one-third of its assets directly or indirectly in other securities (including other asset classes), countries, regions, industries or currencies, investment funds, warrants and money market investments, and hold cash (subject to the restrictions provided in the prospectus).</div> <div>The fund may use derivatives with the aim of achieving investment gains, reducing risk or managing the fund more efficiently.</div> <div>Benchmark</div> | <div>The fund's performance should be assessed against its target benchmark being to exceed the MSCI Emerging Markets (Net TR) index. 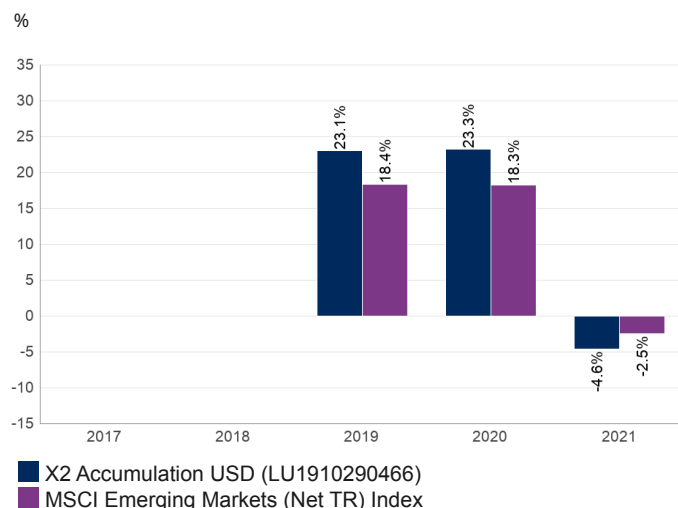
