Objectives and Investment Policy

Objective

The investment objective of the Sub-Fund is to provide a positive absolute return and capital appreciation independent of market conditions over the medium to long term by investing in a portfolio of equities and equity related securities, debt securities and currencies.

Investment Policy


The Fund will invest in asset classes including equities, equity related securities (such as warrants, convertible bonds and exchange traded Funds), derivatives (including those simulating long and short positions which may perform differently from the market as a whole), government and corporate debt securities, collective investment schemes (including exchange traded Funds), commodities, currencies and cash.

Essential features of the Fund:

- The Fund has no specific target market or asset class and any one asset class may account for up to 100% of the assets of the Fund at any given time.
- The Fund may invest up to 10%, in aggregate, of its net assets in UCITS and/or non-UCITS collective investment schemes.
- The Fund has the discretion to invest in a range of investments as described above with no need to adhere to a particular benchmark.
- You can buy and sell shares in the Fund on every business day.
- The Fund may invest up to 100% in below investment grade debt securities.

- The Fund has the discretion to invest in a range of investments as described above with no need to adhere to a particular benchmark.
- The success or failure of the Fund is based on the Investment Manager's expertise in allocating assets across the most opportune asset classes at any given time.
- Derivatives may be used for investment purposes and to manage the risk profile of the fund.
- The Fund may take long and short positions in any asset class.
- Income from the Fund will be added to the value of your investment.
- This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.
- This is an active, return-seeking multi-asset investment fund which has considerable latitude over its asset allocation, which may employ leverage and may own sophisticated instruments such as futures and options. The performance stream is likely to be volatile and the fund is suitable only for investors who have a longer time horizon and can tolerate high risk. **Investors may not get back all the money invested and an investment in this fund should only form part of an investor's total portfolio. - This Fund is categorised in risk class 7 because, in accordance with the investment policy, the value of the investments may fluctuate considerably. Consequently, both the expected return and the potential risk of loss may be high. This indicator is a measure of a Fund's volatility. As the share class has less than 5 years price history, this calculation incorporates the volatility of the Fund's representative portfolio model, target asset mix or benchmark. The higher a Fund's past volatility the higher the number on the scale and the greater the risk that investors in that Fund may have made losses as well as gains. The lowest number on the scale does not mean that a Fund is risk free.

The Fund is subject to the following risks:

- **Liquidity Risk:** At times, some shares may trade infrequently which means it may be more difficult for the Fund to buy and sell them. Prices may also be subject to short term swings.
- **Counterparty Risk:** As the Fund may enter into derivative agreements there is a risk that other parties may fail to meet their obligations. This may lead to delays in receiving amounts due to the Fund, receiving less than is due or receiving nothing.
- **Financial Techniques Impact:** The Fund may invest in derivatives, which may cause the Fund to be leveraged, i.e. the Fund's exposure is greater than its net asset value. A relatively small movement in the value of the derivative's underlying investment may have a much larger impact, positive or negative, on the value of the Fund than if the Fund were to hold the underlying investment itself.
- **Currency Risk:** At the portfolio level any currency hedging decisions with regards to non-base currency exposures are at the Fund manager's discretion. When the Fund is not hedged, as the Fund invests in overseas securities, any movements in exchange rates may cause the value of your investment to increase or decrease.
- **Market risk:** the value of investments and the income derived from them may fall as well as rise. There is no assurance that the investment objective of the Fund will be achieved.
- **Fixed Income Security Risk:** Fixed interest securities are affected by trends in interest rates and inflation. If interest rates go up the value of capital may fall and vice versa. Inflation will also decrease the real value of capital. The value of a fixed interest security is also affected by its credit rating.
- **Custody risk:** there may be a risk of a loss where the assets of the Fund are held in custody that could result from insolvency, negligence or fraudulent action of the custodian or sub-custodian.


- The ongoing charges figure is based on expenses for the year ending 31 December 2021. This figure may vary from year to year. The ongoing charges are taken from the income of the Fund. They exclude any performance fee paid and portfolio transaction costs, except in the case of an entry/exit charge paid by the Fund when buying or selling units in another collective investment undertaking.

The Investment Manager of the Fund has undertaken to absorb any costs that would otherwise cause the Fund to have ongoing charges of 50bps above the annual management charge, excluding research costs. The performance fee paid for this share class in the Fund's last financial year was 0.40%.

You may be charged a dilution levy of up to 0.50% on entry to or exit from the Fund.
