

Monthly Commentary

LGT Dynamic Protection UCITS Sub-Fund Class G (EUR) returned 1.23%. The equity rally continued with the S&P 500 notching a five-month winning streak of 25% and ending the first quarter up 10%, while US Treasury yields rose moderately from the beginning of the year. Besides the AI mania and the momentum-driven equity rally, the Fed further supported markets by maintaining its outlook for a three quarter-point rate cut this year despite strong job gains and US core inflation slightly topping forecasts. Given this, the US dollar rose and yet Gold rallied sharply amidst diverging G10 monetary policy rate level decisions. Despite its low level of risk taking due to suppressed equity market volatility after five months straight without even a 2% retracement in the S&P 500, the fund was able to eke out a positive return from its long position in Gold Hedge and its DynamEq overlay, which helped it end the quarter flat notwithstanding the buoyant equity markets. Most other underlying hedging strategies were either flattish or had only a minor negative impact on performance.





Performance of GIPS composite (USD gross since inception)




Fund description
