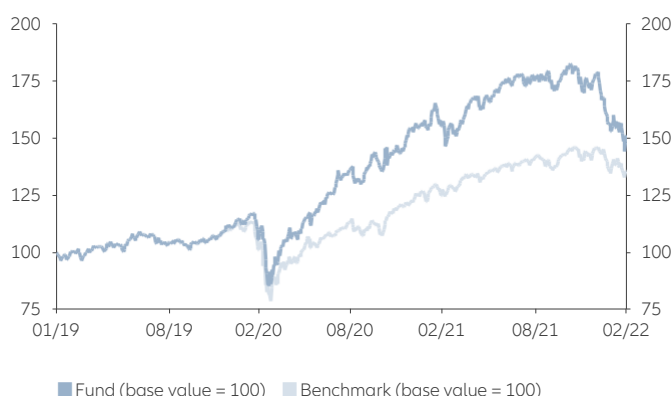

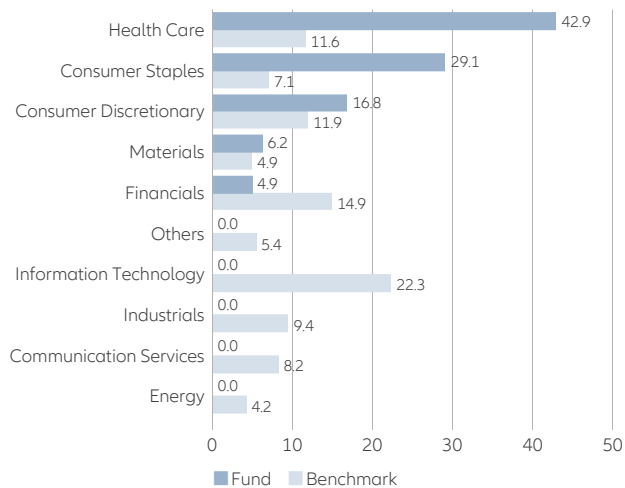

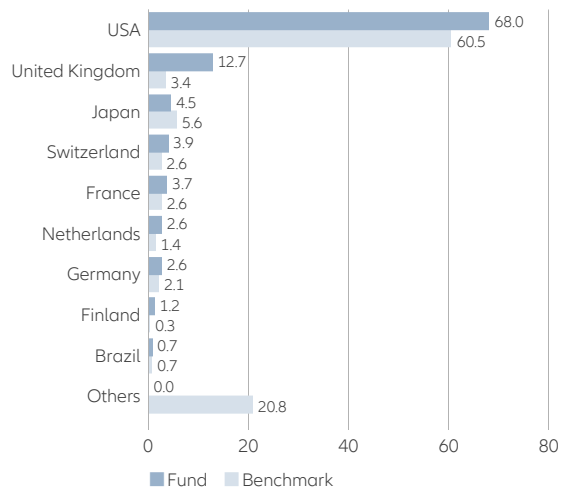

Country/Location Breakdown (%)



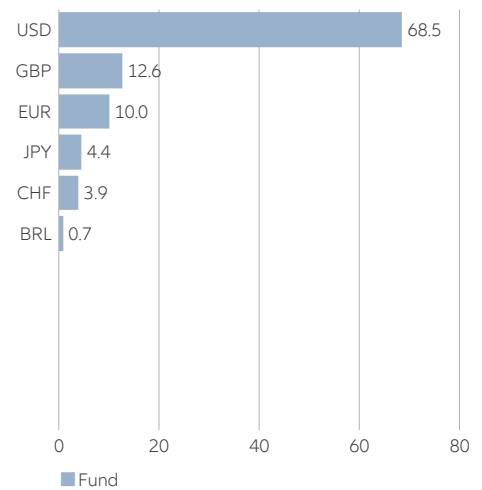
