Fisher Investments Institutional US Small Cap Core Equity ESG Fund, USD 1

Investment Objective: The investment objective of the Fisher Investments Institutional Small Cap Core Equity ESG Fund (the "Fund") is to outperform the Benchmark. There is no guarantee that the investment objective will be achieved.

Benchmark: Russell 2000 Index. The Benchmark measures the performance of the small cap core segment of the United States equity universe. The Russell 2000 Index is a subset of the Russell 3000 Index representing approximately 10% of the total market capitalisation of that index

Investment Policy: The Fund invests primarily in equities and equity-related securities of, or linked to, small market capitalisation issuers located in the United States and may invest up to 10% of its total assets in unlisted equities. The Investment Manager considers environmental, social and governance factors throughout the investment and portfolio construction process. The Fund is actively managed by the Investment Manager, meaning that investment decisions are made on a fully discretionary basis. Accordingly, the portfolio holdings may significantly deviate from the Benchmark.
