Fund objective

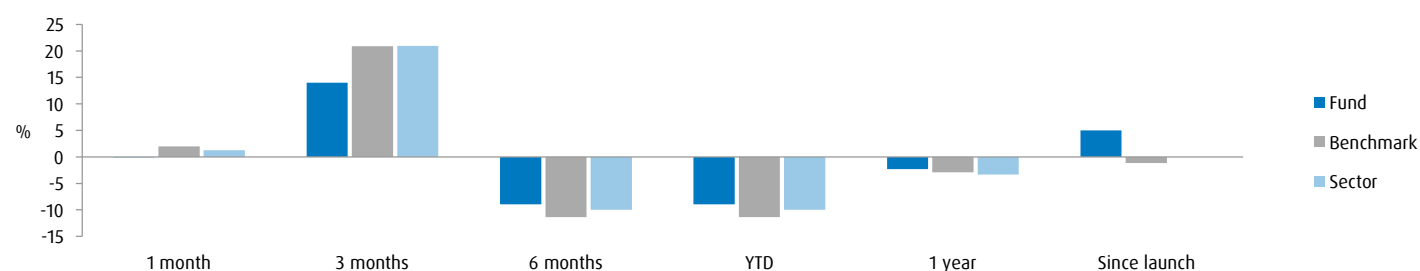
