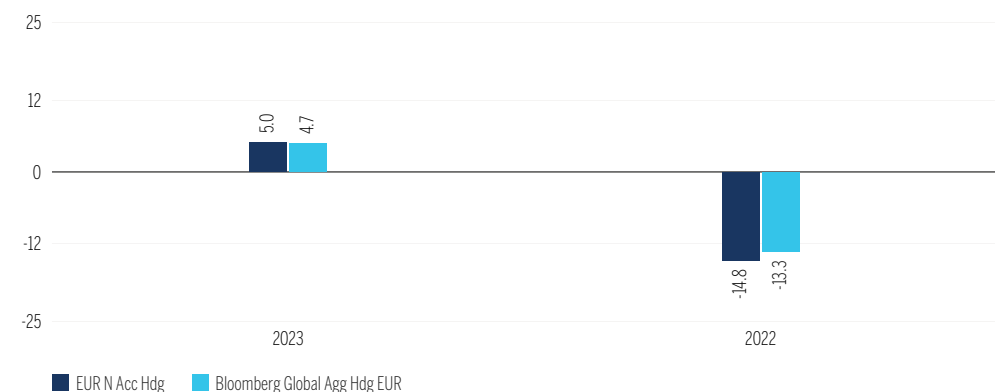

WHAT ARE THE RISKS?

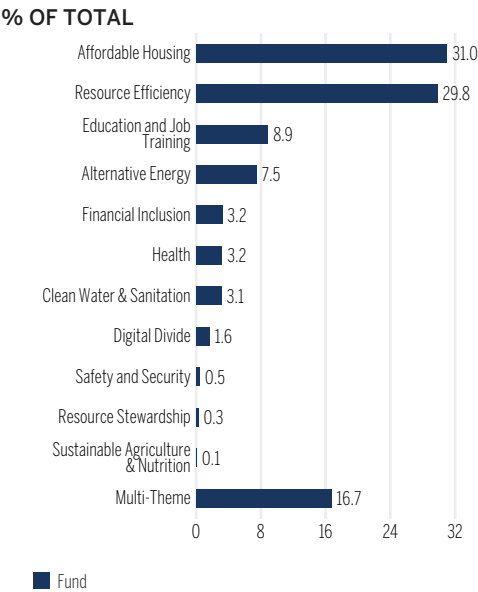

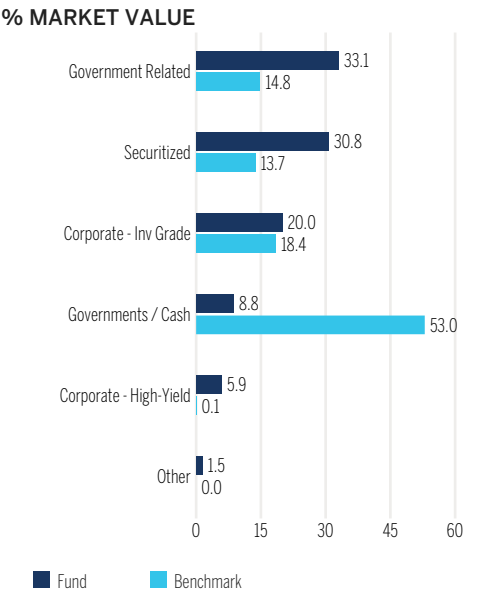

THEME DISTRIBUTION



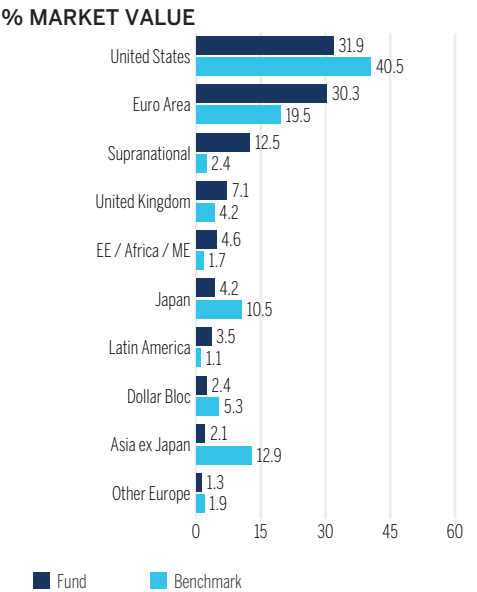

SECTOR DISTRIBUTION



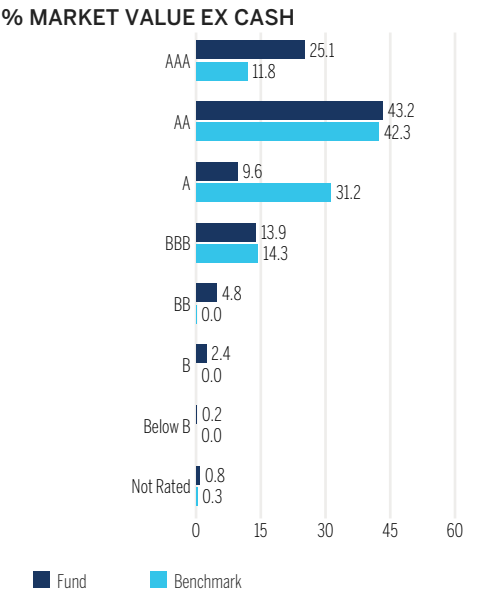
