# **Objectives and Investment Policy**

### **Objective**

• To generate total investment return by capital appreciation over the time with an objective return of 4-5% over US inflation on a 3 to 5 year investment horizon.

#### **Main Investments**

• Variety of different types of investments (including mutual funds, exchange-traded funds, cash, money market instruments or US treasury bills).

#### **Investment Policy**

- The Sub-Fund invests worldwide in (i) fixed income securities
  of any quality, including lower-quality such as noninvestment grade securities, (ii) equity through ETFs, equity
  mutual funds and balanced funds and (iii) alternative
  investments through absolute return funds, REITs and MLPs.
- The Sub-Fund has an active investment strategy and is not managed in reference to a benchmark.


#### **Other Information**

- The Sub-Fund may invest to a lesser extent in instruments issued in emerging markets.
- Derivatives are financial instruments whose characteristics and value depend on the performance of one or more underlying assets (securities, indexes, currencies). They may rely on other companies to fulfil contractual obligations and carry more risk.
- The Sub-Fund may not invest in individual stocks or bonds.
- Income will be included in the value of your share.
- Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within three years.

## **Risk and Reward Profile**



The risk and reward category shown is based on historic data. The risk and reward indicator illustrates where the Sub-Fund is positioned in terms of its possible risk and reward. The higher the Sub-Fund's position on this scale, the greater the possible reward, but also the greater risk of losing money. This risk indicator is calculated using historical data, which cannot be used as a prediction for the future. Therefore the risk classification may change over time. Even if the Sub-Fund is in the lowest risk class you can lose money, as no investments are entirely risk free. The Sub-Fund is in this category because it invests in fixed income securities and the fund's simulated and/or realised return has experienced medium rises and falls historically. The fund may be impacted by movements in the exchange rates between the fund's currency and the currencies of the fund's investments.

This rating does not take into account other risk factors which should be considered before investing, these include:

- Credit risk the risk of loss arising from default that may occur
  if an issuer fails to make principal or interest payments when
  due. This risk is higher if the Sub-Fund holds low-rated, noninvestment-grade securities.
- Liquidity risk the risk that arises when adverse market conditions affect the ability to sell assets of the Sub-Fund at a certain time and for a reasonable price.
- **Derivatives risk** the risk of loss in an instrument where a small change in the value of the underlying investment may have a larger impact on the value of such instrument. Derivatives may involve additional liquidity, credit and counterparty risks.
- Emerging markets risk the risk related to investing in countries that have less developed political, economic, legal and regulatory systems, including less developed custody and settlement practices, higher volatility and lower liquidity than non emerging market securities.
- Commodities exposure risk the Sub-Fund may seek indirect access to commodities, whose value can be extremely volatile and affected by market movements.
- **Real estate risk** the Sub-Fund may seek indirect access to a sector of the economy which can be affected by downturn in macro economic or property market conditions.

## **Charges**

The charges you pay are used to pay the costs of running the Sub-Fund, including the costs of marketing and distributing it. charges reduce the potential growth of your investment.

The **entry** and **exit charges** shown are maximum figures. In some cases you might pay less – you can find this out from your financial adviser.


The **ongoing charges** figure is based on expenses for the year ending December 2021. This figure may vary from year to year.
