Summary of Investment Objective:

The fund's goal is to achieve growth of the fund's value in the long term, through investment in a concentrated portfolio comprised primarily of shares of European companies. The fund will invest at least 80% of its assets in shares of companies located or listed in Europe or, that conduct the predominant part of their economic activity in Europe. Such investment may be directly in such shares or indirectly via derivatives (financial instruments whose value is derived from the value of other assets).



Investment in company shares: The fund invests in shares of companies, and the value of these shares can be negatively affected by changes in the company, its industry or the economy in which it operates.
