Stock selection is exclusively bottom up, independent of benchmark weightings. The fund takes ESG factors into consideration while implementing the aforementioned investment objectives.



Market review

Global equity markets surged in November, lifting the MSCI World by more than 9% mom in USD. Investors began to price in a soft economic landing in the US, bolstering a Goldilocks scenario where inflation has been tamed and the Fed can start to cut interest rates again from mid-2024. Record-low unemployment rates across the US, coupled with the hefty pay raises labor unions have recently secured, could, however, set wage-price spirals in motion. Against this backdrop, Asian healthcare stocks also had a good run in November and closed the month almost 8.9% higher.

Pro Medicus announced that it has signed an 8-year contract worth AUD 20 mn with Oregon Health & Science University (OHSU). OHSU includes the OHSU Hospital and the OHSU Doernbecher Children's Hospital (with a total of 576 licensed beds) as well as a system of clinics across Oregon and southwest Washington state. OHSU is the seventh contract won in 2023 with a minimum annual value of USD 2.5 mn. The new customer is another public academic medical center, which indicates that the Visage system remains appealing to hospitals.

The FDA announced that it had launched an investigation into the risk of T-cell malignancies in patients treated with currently approved BCMA or CD19-directed autologous CAR T-cell therapies. The FDA said it would be evaluating the need for regulatory action, but also that the overall benefit of these treatments continued to outweigh the potential risks for their approved uses in various oncological indications (lymphoma, myeloma, leukemia). It's possible that FDA is focusing its investigation on treatments in non-oncology settings where the risk tolerance for developing cancer is lower, for example in autoimmune diseases. Legend Biotech, the market leader for multiple myeloma cell therapy, was among the companies that traded lower in the wake of the FDA announcement. We are nevertheless confident that Carvykti's superior effectiveness in treating this incurable disease will remain a decisive factor.

Investors have urged Celltrion Group to simplify its complicated and intransparent corporate structure for many years. Those calls are finally being heeded. At the end of the proposed merger process, only one Celltrion stock will be listed on the stock exchange and investor attention will then be more focused on the biosimilar giant's business fundamentals. High hopes have been pinned on Celltrion's subcutaneous formulation of its infliximab (Remicade) biosimilar, which has already been successfully launched in Europe. It will be launched in the US as a new drug around the middle of 2024 at a list price of USD 26 000 a year.

ZaiLab was added to the portfolio during the past month and an existing position in Mindray was increased. Shareholdings of Wuxi Apptec, Takeda, Apollo Hospital and Innovent were reduced.

Positioning & outlook

Asia is the most dynamic growth region in the world and it accounts for more than half of the world's population. Asian emerging markets are forecast to account for more than 50% of global GDP by 2050. As household incomes rise, the economic growth model of Asian countries will shift from manufacturing to the services sector. A growing middle class fuels demand for modern medicine. Healthcare ranks increasingly high on their wish list. Billions are being invested in infrastructure, technology and research to modernize the healthcare systems in emerging market countries. This is giving a greater swath of the population access to better healthcare. Meanwhile rapid population aging is also stoking demand for healthcare. In 30 years' time there will be 400 to 500 million people over 60 in China alone, and they will have a growing need for modern health services and medicines.

Japan, which has been referred to as "the world's demographic laboratory", has championed cutting-edge innovation for decades. The Land of the Rising Sun boasts technology leadership in numerous fields, ranging from therapeutic antibody technology, immunotherapy and robotics to digitalization, diagnostics and medical imaging systems. The fund offers defensive access to Asian emerging markets as well as exciting investment opportunities in technology leaders throughout the entire region. It invests in the entire healthcare system value chain, from generic drug producers and biotechnology companies to medical device manufacturers and digital health specialists.
