OBJECTIVE AND INVESTMENT POLICY

Objective: To seek a maximum total rate of return primarily from current income, while minimising fluctuations in capital values.

Investment Policy: The fund invests primarily in a diversified portfolio of North American and European short-term investment grade fixed income securities. An investment grade fixed income security is one which carries a lower (but not zero) degree of risk than high yield fixed income securities, as such investment grade fixed income securities typically carry a lower rate of interest than high yield fixed income securities. The fund is permitted to invest in a range of fixed income instruments including instruments issued by the US Treasury, US Government Agencies, US Government Sponsored Enterprise, US Local, City and State Governments and Agencies and US and non-US corporations. The fixed income instruments in which the fund invests may include corporate bonds and notes, treasury obligations, sovereign issues, covered bonds, convertible instruments and commercial paper. The fund is also permitted to invest in debt securities backed by a pool of assets (which can range from loans and mortgages to credit card receivables), other funds, cash and cash-equivalent securities and money market instruments.

- Up to 10% of the fund's net assets can be invested in securities rated lower than BBB- by Standard & Poors (S&P) or Fitch, or rated lower than Baa3 by Moody's Investor Service or the equivalent rating of another internationally recognised rating agency, provided these securities are rated BB- or higher by S&P or the equivalent rating of another internationally recognised rating agency. The average portfolio duration of the fund is expected to range between 0 and 3 years under normal market conditions.

Duration measures the sensitivity of the assets to interest rate risk. The longer the duration the higher the sensitivity to changes in interest rates.

- The fund may use derivative instruments for both investment and hedging purposes. The return on a derivative is linked to movements in an underlying instrument referenced by the derivative such as currency or interest rates. The base currency of the fund is USD.

Distribution Policy: Income will be declared and distributed as a dividend quarterly.

Dealing Frequency: Daily. Investors can buy and sell their shares on demand on each Business Day (as defined in the prospectus and supplement).

Benchmark: Bloomberg Barclays U.S. Government 1-3 Year Index'. The fund is actively managed and is not designed to track the Benchmark so its performance may deviate materially from the Benchmark. The investment manager has complete discretion in making investments and is not constrained by the Benchmark. The fund may invest significantly in instruments which are not included in the Benchmark. The Benchmark is used only for risk management and performance comparison purposes. The investment manager may consider, for example, issuer exposures, duration, sector weights, country weights, credit ratings and tracking error in each case relative to the Benchmark but does not use the Benchmark as an investment limitation.

RISK AND REWARD PROFILE

- During exceptional market conditions there may be insufficient buyers and sellers to allow the Fund to buy and sell investments readily which could affect the Fund's ability to meet investors' redemption requests

- Derivative instruments can make a profit or a loss and there is no guarantee that a financial derivative contract will achieve its intended outcome. The use of derivatives can increase the amount by which the Fund's value rises and falls and could expose the Fund to losses that are significantly greater than the cost of the derivative as a relatively small movement may have a larger impact on derivatives than the underlying assets.
- Changes in exchange rates between the currency of the Fund and the currencies in which the assets of the Fund are valued can have the effect of increasing or decreasing the value of the Fund and any income generated.
- Debt securities are subject to risks that the issuer will not meet its payment obligations (ie, default). Low rated (high yield) or equivalent unrated debt securities of the type in which the fund will invest generally offer a higher return than higher rated debt securities, but also are subject to greater risks that the issuer will default.
