## Investment Policy

The fund aims to generate both income and capital growth, while seeking to preserve capital through adequate diversification. To achieve this objective the fund invests at least two-thirds of its assets in contingent capital securities and other hybrid, subordinated financial instruments issued by financial institutions. These securities are predominantly rated below investment grade. The main focus is on banks and insurance companies with solid capitalization, where the additional risk of this lower credit segment is expected to be compensated with higher returns. In order to manage risk and liquidity the fund maintains flexibility to invest across the capital structure (eg. adding senior bonds) and may use financial derivative instruments to hedge existing positions.

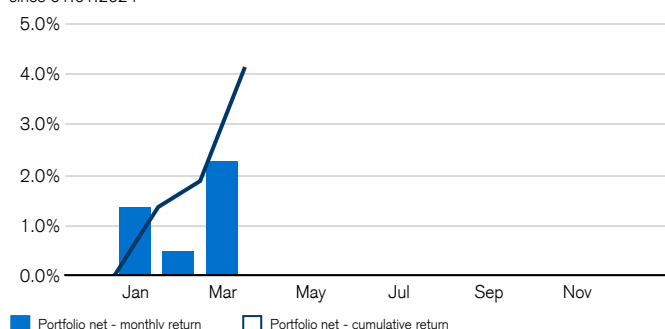

## Potential Risks

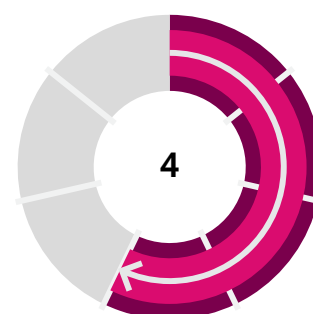

## Performance review

In March, most subordinated financial bank bonds achieved positive total returns as credit as the compression in credit spreads persisted. Total returns of EUR Additional Tier 1 bonds stood at +2.79% while EUR Tier 2 ended the month at +1.21%. Similarly, the subordinated insurance bonds spread tightened significantly with EUR Restricted Tier 1 bonds ending the month at +2.8%. EUR Bank senior non-preferred bonds returned and stood at +1.07% and EUR insurance senior bond ended with +1.11%. The fund's performance was predominantly driven by a spread change (+143 bps), duration (+26 bps), and rates carry (+34 bps). The contribution from the interest rate overlay was slightly negative at -5 bps. Geographically, German issuers were the best contributors in terms of performance, followed by British and Dutch issuers, while Finish and Portuguese issuers were the weakest contributors.

Market Review

March was another strong month for risk assets and in particular credit. Hopes for a soft landing continued to be supported by the upside surprise of US data with February non-farm payrolls up by 275 K and PMIs continuing to rise in the euro zone with flash PMI for March up to 49.9. Despite concerns about inflation back on the rise, investors continued to push back on the timing of the expected rate cuts from central banks. While the Fed did not cut rates at its meeting March and with a first cut most likely to take place in June, the Bank of Japan ended its negative interest rate policy in March. In contrast, the Swiss National Bank became the first central bank with a G10 currency to cut rates by 25 bps to 1.5% in March with Swiss CPI inflation standing at 1.2% in February. The sentiment toward subordinated bond structures remained more constructive, however, Q4 bank reports continued to fuel concerns about commercial real estate (CRE) particularly in the US, as the consequences of higher interest rates are yet to materialize. Consequently, US regional banks and European issuers with significant US CRE exposure lost ground in the middle of the first quarter, however partially regained ground in March. EUR AT1 spreads tightened by 28 bps, EUR Restricted Tier 1 (RT1) tightened by 19 bps, EUR Bank Tier 2 spreads ended the month 6 bps tighter, and EUR bank senior non-preferred bonds tightened by 7 bps (Sources: Credit Suisse Contingent Convertible Euro Index, Credit Suisse Insurance Capital EUR Restricted Tier 1 Index, Credit Suisse Bank Capital Euro Lower Tier 2 Index; Credit Suisse Bank Capital Euro Senior Preferred Index. Data as of: March 31, 2024). In the current volatile environment, we remain in our overall defensive position. Issuer and bond selection remains key, and our preference remains for systemically important European issuers with healthy balance sheets and significant backend spread cushions.
