- The fund is passively managed.

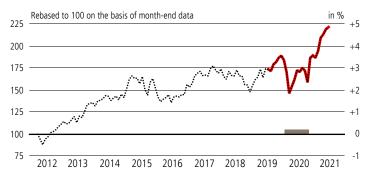

The EURO STOXX 50[®] ESG Index is based on the EURO STOXX 50[®] Index. A set of standardized ESG exclusion screens, based on the responsible policies of leading asset owners, are applied with the aim of reducing reputational and idiosyncratic risks. In addition to the exclusion screens, 10% of companies with the lowest ESG scores are excluded and are replaced by companies with a higher ESG score from the same ICB Supersector as the excluded companies.
