FUND PROFILE

The Credicorp Capital Latin American Equity Fund aims to provide investors with long-term capital growth from a diversified and actively managed portfolio of Latin American securities. The fund will invest principally (at least 70% in value) in equities in the markets and sectors in the Latin American region and in companies established outside those markets, but which derive a significant proportion of their earnings from those markets. The Latam Equity Subfund will start investing in Mexico, Colombia, Chile, Peru, Brazil, Argentina, the United States of America, Canada and the United Kingdom. In the future, it could invest in other Latin American countries. The use of derivatives is restricted to hedging purposes only.










BREAKDOWN OF HOLDINGS BY CAPITALIZATION
