





Performance review

Under these conditions, the Latin America Corporate Bond Fund generated a negative absolute return and slightly lagged the benchmark. From the country perspective, our sector allocation and security selection made a slightly negative contribution to relative performance. At the sector level, our overweight in Sovereigns and Metals and Mining, as well as our underweight within the Utilities and Consumer sectors, had a positive impact on relative performance, while security selection within Oil & Gas and Transportation contributed negatively to relative performance. From a rating perspective, our allocation benefited from the overweight in high-yield bonds while security selection within both high-yield and investment-grade instruments contributed negatively to the relative performance. Our duration and yield-curve positioning contributed negatively to relative performance in April.

Market Review

In April, the performance of Latin American corporate bonds was negative as tighter credit spreads were not able to offset the negative impact from rising US Treasury yields. In the US, 2-year Treasury yields rose by 41 basis points (bps) while yields on 10-year and 30-year Treasury bonds increased by 48 bps and 44 bps, respectively. The US Treasury curve remains inverted with the yield differential between 2- and 10-year US Treasury notes ending the month at –36 bps. A main driver for the month was US inflation data, which provided further evidence that US inflation is stickier than previously anticipated. This led to a re-pricing of expected interest rate cuts and a meaningful upward move in yields preads tightened, with spreads of investment-grade rated issuers tightening by 15 bps while high-yield spreads tightened 38 bps. On a total return basis, Argentina , Honduras, and Ecuador were the best-performing countries in Latin America, while Mexico and Brazil were the laggards.
