Baillie Gifford Worldwide Global Dividend Growth Fund ("the Fund") is a sub-fund of Baillie Gifford Worldwide Funds PLC (the Company). The Fund is managed by Baillie Gifford Investment Management (Europe) Limited.

Objectives and investment policy Objective

• The Fund aims to achieve a higher level of income than global equities whilst, over the longer term, achieving growth in both income and capital.

Policy

- The Fund invests mainly in shares of companies worldwide.
- The Fund is actively managed and no index is used for the purposes of determining or constraining the composition of the Fund's portfolio. The Fund's performance (after deduction of costs) and yield is measured against the MSCI ACWI Index. The Fund seeks to outperform the index.



Risk and reward profile

This investment style, selecting companies with perceived greater long-term growth potential ahead of any short-term returns, in combination with the relative concentration of the Fund, may lead to prolonged periods of underperformance in certain market conditions, both in relation to the Fund's index and in absolute terms


