# The Jupiter Global Fund - Jupiter Global High Yield Short Duration Bond (the 'Fund'), a sub-fund of The Jupiter Global Fund (the 'Company')

#### Objectives and investment policy

To achieve income and capital growth over the medium to long term by investing in a portfolio of global high yield bonds that has, on average, short durations.

The Fund will invest at least 70% of its value in a portfolio of global corporate high yield bonds that has, on average, a remaining maturity of no more than 5 years.

The Fund may also invest in other transferable securities, money market instruments, cash or near cash instruments, deposits and units in other collective investment schemes.

Short duration debt securities are typically bonds that could have a relatively short time to maturity (the date on which a bond is repaid to the investor) and a relatively lower duration\*.

High yield bonds are bonds with a low, i.e. below investment grade, credit rating from a credit ratings agency.

The Fund may invest up to 20% of its value in each of the following: (i) securities that are convertible into equity securities; (ii) certificates of deposits; and/or (iii) bankers' acceptances; (iv) emerging market countries \*\*; (v) investment grade corporate bonds.

The Fund may invest up to 10% of its value in: bonds issued by and/or guaranteed by sovereign issuers; bonds which are unrated by any of Moody's, Standard & Poor's and Fitch; asset backed securities and/ or mortgage backed securities; in contingent convertible bonds. Convertible bonds are corporate bonds with an option that allows an investor to convert the bond into shares at a given price at specified times during the life of the convertible bond.

\*The Duration measures the sensitivity of a bond or bond fund to changes in interest rates. The longer a bond's duration, the more sensitive it is to interest rate movements.

\*\*"emerging market countries" means those countries which are included in the JPMorgan CEMBI Broad Diversified Total Return Index, JPMorgan Emerging Markets Bond Index Global Diversified Index or J.P. Morgan Next Generation Markets Index at the time of the relevant investment.

Any income arising in relation to this share class will be accumulated (i.e. automatically reinvested and reflected in the price of the shares).

This hedged share class (HSC) will use currency hedging techniques to reduce the effect of fluctuations in currency exchange rates on performance if compared to the main currency of the Fund, both positive and negative.

Investors are able to buy and sell shares during any business day. If you tell us to buy or sell shares before 1pm (Luxembourg time) on any business day we will make the transaction on the same day. If you tell us to buy or sell shares after 1pm (Luxembourg time) we will make the transaction on the following business day.

## Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area in the table below shows the Fund's ranking on the Risk and Reward Indicator.

- The lowest category does not mean 'no risk'.
- The Fund is in this category due to the nature of its investments and previous levels of volatility (how much the value of the Fund rises and falls).
- Market and exchange rate movements can cause the value of an investment to fall as well as rise, and you may get back less than originally invested.
- The Fund can invest a significant portion of the portfolio in high yield bonds and bonds which are not rated by a credit rating agency. While such bonds may offer a higher income, the interest paid on them and their capital value is at greater risk of not being repaid, particularly during periods of changing market conditions.
- Bonds are very sensitive to interest rate changes and it is possible that issuers of bonds will not pay interest or return the capital promised.
   Bonds may also be downgraded by rating agencies. These events can reduce the value of bonds and have a negative impact on performance.
- In difficult market conditions, reduced liquidity in bond markets may make it harder for the manager to sell assets at the quoted price. This could have a negative impact on the value of your investment. In extreme market conditions, certain assets may become hard to sell in a timely manner or at a fair price. This could affect the Fund's ability to meet investors' redemption requests upon demand.
- Investment in emerging markets carries greater risk than investment in more traditional western markets. This may result in large falls in the Fund's value over short periods of time.
- All the share class charges are taken from income. Should there not be sufficient income in the Fund this may cause capital erosion.
- The value of income payments will fluctuate.

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.
