Objectives and Investment Policy

Objective: The fund aims to achieve capital growth over time and provide income.

Investment Policy: The fund invests at least 70% of its assets, in investment grade, below investment grade emerging markets debt securities and denominated in local currency. The fund may also invest in emerging market debt securities denominated in non-local currency and on an ancillary basis money market instruments.

The fund invests at least 50% of its assets in securities of issuers with favourable environmental, social and governance (ESG) characteristics.

The fund may invest in the following assets according to the percentages indicated:

Below investment grade debt securities issued or guaranteed by any single country (including its government, a public or local authority or a nationalised industry of that country): more than 10%

Listed China onshore bonds (directly and/or indirectly): less than 30% (in aggregate)

Corporate bonds of emerging market issuers: up to 25%.

The fund's exposure to distressed securities is limited to 10% of its assets.

Investment Process: In actively managing the fund, the Investment Manager uses in-house research and investment capabilities to identify suitable opportunities across bond issuers, sectors, geographies, and security types. This may include an assessment of bond issuers' creditworthiness, macroeconomic factors, and valuations. In determining favourable ESG characteristics, the Investment Manager takes into account ESG ratings provided by Fidelity or external agencies. Through the investment management process the Investment Manager aims to ensure that investee issuers follow good governance practices. The fund adheres to the Fidelity Sustainable Investing Framework standards. For more information, see "Sustainable Investing and ESG Integration".

Derivatives and Techniques: The fund may use derivatives for hedging, efficient portfolio management and investment purposes.

Benchmark: J.P. Morgan Government Bond Index - Emerging Markets Global Diversified an index that does not take into account ESG characteristics. Used for: risk monitoring, investment selection and performance comparison.

Risk Management Method: Commitment.

Base Currency: EUR.

Distribution: As this is a non-distributing share class, dividends are re-invested.

The reference currency of the fund is hedged to the reference currency of the share class. This hedging has the effect of translating (or "replicating") the returns expressed in the fund's reference currency into returns expressed in the reference currency of the share class.

The long and short active currency positions may not be correlated with the underlying securities positions held by the fund.

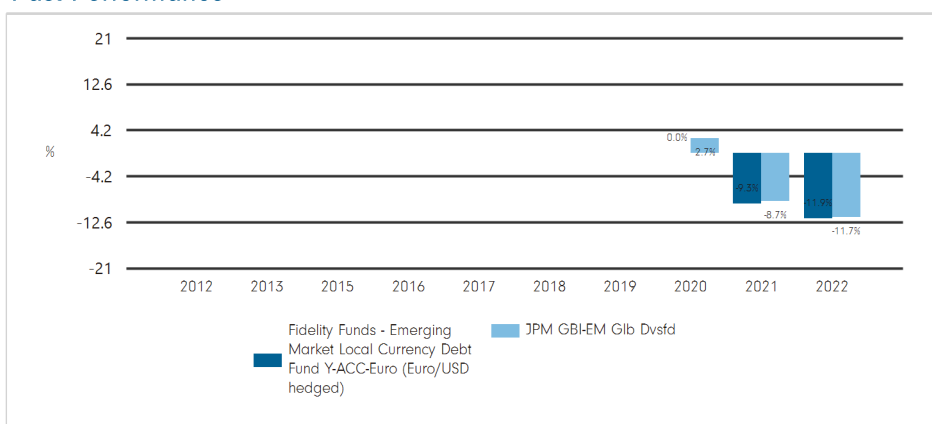
