### Fund description

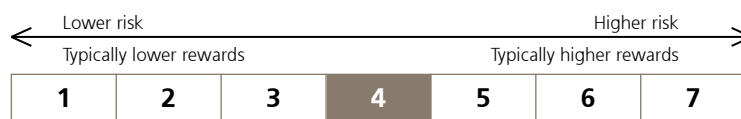
- This actively managed, defensive equity fund invests in companies from across the globe that offer a high dividend yield.
