Risk considerations

ABS and MBS risk: The fund may invest in mortgage or asset-backed securities. The underlying borrowers of these securities may not be able to pay back the full amount that they owe, which may result in losses to the fund.



Source and ratings information

Impact scores: These are generated using Schroders' proprietary tool SustainEx™.
