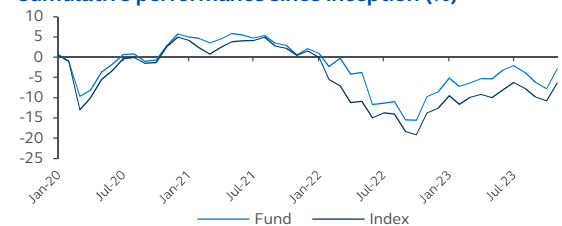

Cumulative performance since inception (%)



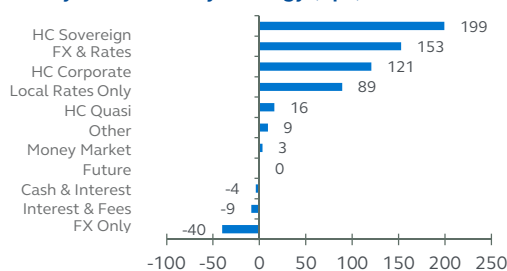
