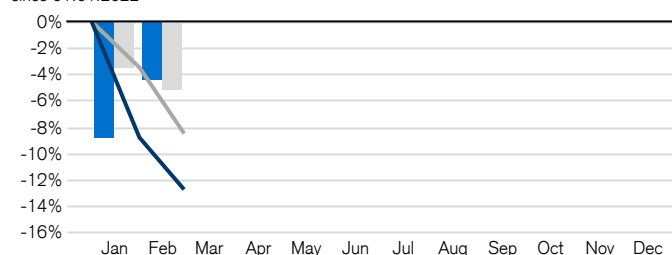
Investment Policy

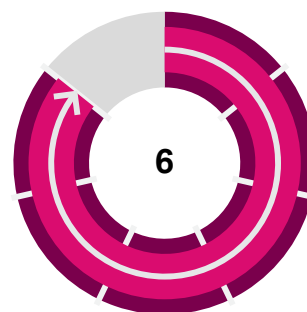
