The Fund may invest up to 100% in companies of any size.

The Fund may use derivatives to reduce risk or to manage the Fund more efficiently.

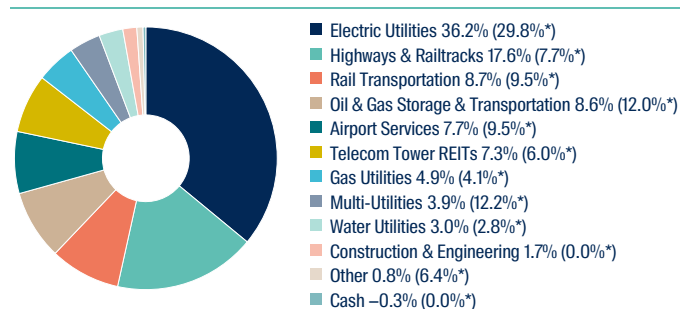

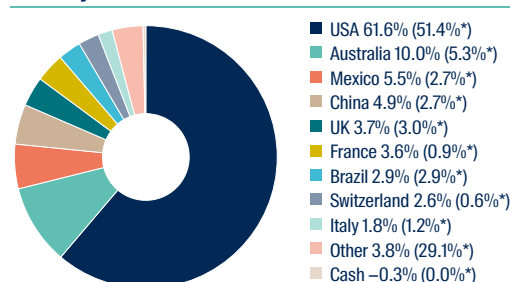
