#### **Objectives and Investment Policy**

- The Portfolio seeks to provide capital growth over the longer term.
- The Portfolio will mostly hold shares or similar instruments relating to companies anywhere in the world, which in the view of the Investment Adviser are beneficiaries of technology proliferation.
- The Portfolio will be concentrated and may have significant exposure to specific sectors including, but not limited to, technology, media, telecommunications and communication services sectors. Concentration and exposure to specific sectors may change over time.
- The Portfolio will not invest more than one-third of its assets in other types of companies, money market instruments and non-share related instruments.
- The Portfolio may invest, up to 30%, in mainland China equity securities directly through the Stock Connect scheme or the Renminbi qualified foreign institutional investor program, or indirectly through access products.
- The Portfolio promotes environmental and/or social characteristics, however, does not commit to making any sustainable investments. The Portfolio may use derivatives for efficient portfolio management purposes, to help manage risks and for investment purposes in order to seek to increase return. A derivative instrument is a contract between two or more parties whose value depends on the rise and fall of other underlying assets.

- The Investment Adviser has full discretion over the composition of the assets in the Portfolio. While the Portfolio will generally hold assets that are components of the Benchmark, it can invest in such components in different proportions, and it can hold assets which are not components of the Benchmark. Therefore returns may deviate materially from the performance of the specified reference Benchmark.
