## **Objectives and investment policy**

#### **Investment objective**

The Portfolio seeks to increase the value of your investment over time through a combination of income and capital growth (total return) while seeking to maintain a net exposure to global equity markets (or beta) that is close to zero.

#### **Investment policy**

Under normal market conditions, the Portfolio typically invests in equity securities of companies that are organised, have substantial business activities, or are impacted by developments, in developed countries and emerging market countries. These companies may be of any market capitalisation and industry.

The Investment Manager seeks (i) to select securities that it believes are high quality, have low volatility and reasonable valuations and offer attractive shareholder returns and (ii) to reduce most of the effects of overall equity market movements, or beta, by using derivatives to reduce the Portfolio's exposure to the MSCI World Unhedged Index.

The Portfolio may be exposed to any currency.

The Portfolio uses derivatives for hedging (reducing risks) and efficient portfolio management.

#### **Responsible Investing**

The Portfolio is classified as Article 8 under SFDR. For more information, please refer to SFDR Pre-Contractual Disclosures in the prospectus.

#### Benchmark

ICE BofA Merrill Lynch 3-Month U.S. Treasury Bill used for performance comparison and volatility measurement.

#### **Portfolio currency**

The reference currency of the Portfolio is USD.

#### Share class currency

The reference currency of the share class is EUR.

**Hedged Share Class:** This share class seeks to reduce the effect of exchange rate fluctuations between the Portfolio's base currency and the currency of the share class.

#### **Distribution policy**

This share class is a non-distributing share class. Income and capital gains derived from the Portfolio are reinvested.

#### Redemption

Shares may be redeemed on any day when both the New York Stock Exchange and Luxembourg banks are open for business.

#### **Terms to understand**

**Beta:** Estimated equity market exposure to the MSCI World Unhedged Index as determined by the Investment Manager periodically.

**Derivatives:** Financial instruments whose value is linked to one or more rates, indices, share prices or other values.

Equities: Securities that represent an ownership stake in a company.

**Emerging market countries:** Nations whose economies and securities markets are less established.

**SFDR:** Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on SFDR Pre-Contractual Disclosures in the financial services sector.

Volatility: Measure of the pricing behavior of a security.



#### What does this risk indicator mean?

This synthetic risk and reward indicator (SRRI) scale rating indicates how the Portfolio may perform and the risk of losing some or all of your capital. Generally the potential for higher gains also means a larger risk of losses. The lowest category does not mean a risk free investment.

The above rating is an estimate, not a guarantee. It is calculated using industry-standard methods and is based on medium-term volatility (how sharply the Portfolio's actual or estimated share price has gone up and down over five years).


The entry and exit charges shown are maximum figures. In some cases, you might pay less – you can find this out from your financial advisor.
