Objectives and investment policy

The Fund seeks to grow your capital and generate income by investing primarily in worldwide -including Emerging countries- regulated UCITS and non-UCITS funds, with no restrictions about sector, which have as investment objective to invest in equities or equivalent and/or in bonds and other debt securities.

The non-UCITS funds will have an investment policy and a risk exposure similar to the UCITS funds and will be submitted to a regulatory supervision equivalent to a UCITS.

The Fund is actively managed.

The Fund is allowed to invest in currencies other than its base currency (USD). These investments may or may not be hedged at the Investment Manager's discretion.

The Fund is not managed in reference to a benchmark.

The Fund can invest in Contingent Convertible bonds ("CoCos"), through funds up to 10% of its net assets.

On an ancillary basis the Fund may also invest in money market instruments, as well as investment grade government bonds up to 40% of its net assets. The Fund's base currency is USD.

As a Fund of bond and equity funds, its holdings can move in line with or return less than the broad stock market, so investors should be aware that the value of their holdings could fall and that they may not get back their initial investment.

Any income received by the Fund is reinvested (capitalisation share class). Investors in the Fund can subscribe and redeem units on any business day in Luxembourg.

The recommended holding period is minimum 3 years.

Risk and reward profile

Significant risk(s) for the Fund not taken into account in this indicator include the following:

Counterparty risk: The use of over-the-counter derivatives exposes the Fund to a risk that the counterparty to the transactions will fully or partially fail to honour its contractual obligations. This may result in a financial loss for the Fund.

Currency risk: The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

Emerging countries risk: The Fund invests in overseas countries which carry a higher risk than investing in larger established countries. Investments in Emerging countries are likely to experience greater rises and falls in value and may suffer trading problems. A Fund which invests in Emerging countries rather than more developed countries may encounter difficulties when buying and selling investments. Emerging countries are also more likely to experience political uncertainty and investments held in these countries may not have the same protection as those held in more developed countries.

Liquidity risk: Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to trade at advantageous times or prices.

Charges


