UBAM is managed by UBP Asset Management (Europe) S.A.

Objectives and investment policy

The Fund seeks to grow capital and generate income by investing primarily in Frontier countries fixed or variable rate bonds in hard currency such as (but not limited to) EUR and USD issued by Public Authorities or quasi sovereign entities. Exposure can be direct or made through derivatives such as CDS (Credit Default Swap).

The Fund is actively managed and will invest a minimum of 2/3 of its net assets in products/issuers with a minimum rating of B- (S&P or Fitch), B3 (Moody's) or an equivalent rating by another rating agency and up to 1/3 of its net assets in products/issuers with a lower rating.

The Fund may invest up to 15% of its net assets in non-rated products/issuers.

Bonds denominated in a hard currency other than USD (e.g. EUR) will be hedged. Overall, up to 20% of the Fund's investments may be carried out in local countries' currencies.

The Fund is not managed in reference to a benchmark.

The Fund may invest its net assets up to:

- 100% in Frontier countries. *This exposure can be increased up to 120% through derivatives*
- 100% in High yield. *This exposure can be increased up to 120% through derivatives*
- 20% in Frontier corporate bonds
- 20% in Contingent Convertible capital bonds (CoCos).

High yield bonds are issued by entities whose activity is more sensitive to the economic cycle and pay higher interest. The return on such securities, in the same way as their level of risk, is therefore higher than traditional bond products.

The Fund's base currency is USD.

Any income received by the Fund is reinvested (capitalisation share class).

Investors in the Fund can subscribe and redeem units on any business day in Luxembourg except days where the decisive market is closed: United States (US).

The recommended holding period is minimum 3 years.

Significant risk(s) for the Fund not taken into account in this indicator include the following:

Counterparty risk: The use of over-the-counter derivatives exposes the Fund to a risk that the counterparty to the transactions will fully or partially fail to

honour its contractual obligations. This may result in a financial loss for the Fund.

Credit risk: The Fund invests in bonds, cash or other money market instruments. There is a risk that the issuer may default. The likelihood of this happening will depend on the credit-worthiness of the issuer. The risk of default is usually greatest with bonds that are rated as sub-investment grade.

Currency risk: The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

Emerging and Frontier countries risk: The Fund invests in overseas countries which carry a higher risk than investing in larger established countries. Investments in Emerging countries are likely to experience greater rises and falls in value and may suffer trading problems. A Fund which invests in Emerging countries rather than more developed countries may encounter difficulties when buying and selling investments. Emerging countries are also more likely to experience political uncertainty and investments held in these countries may not have the same protection as those held in more developed countries. Emerging countries risk are magnified in Frontier countries.

Liquidity risk: Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to trade at advantageous times or prices.

Charges

The charges and commissions are used to cover the Fund's operating costs, including marketing and distribution of shares. These charges reduce the potential growth of your investment.

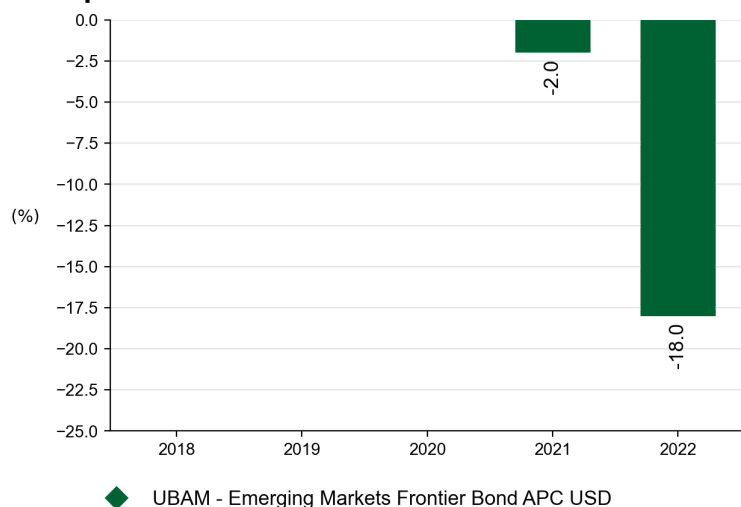
