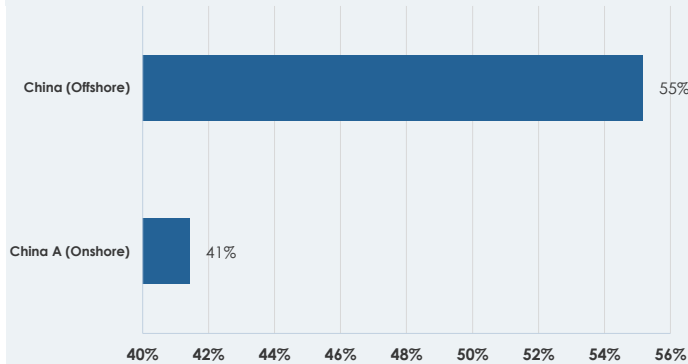

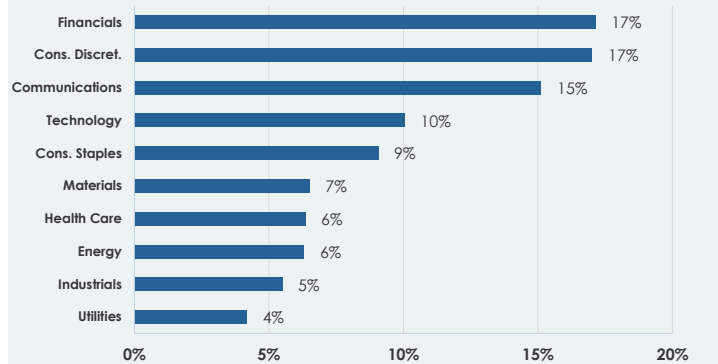

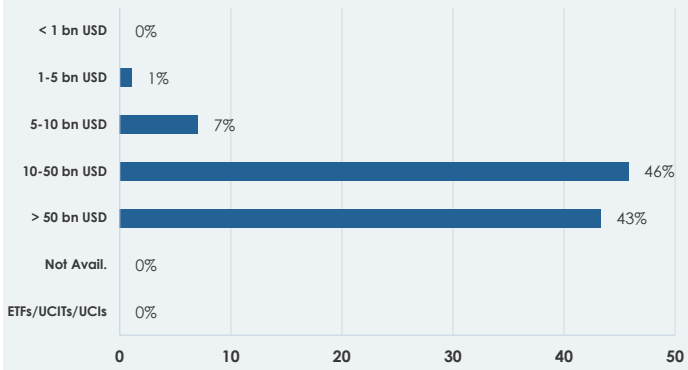
## Breakdown by Country
