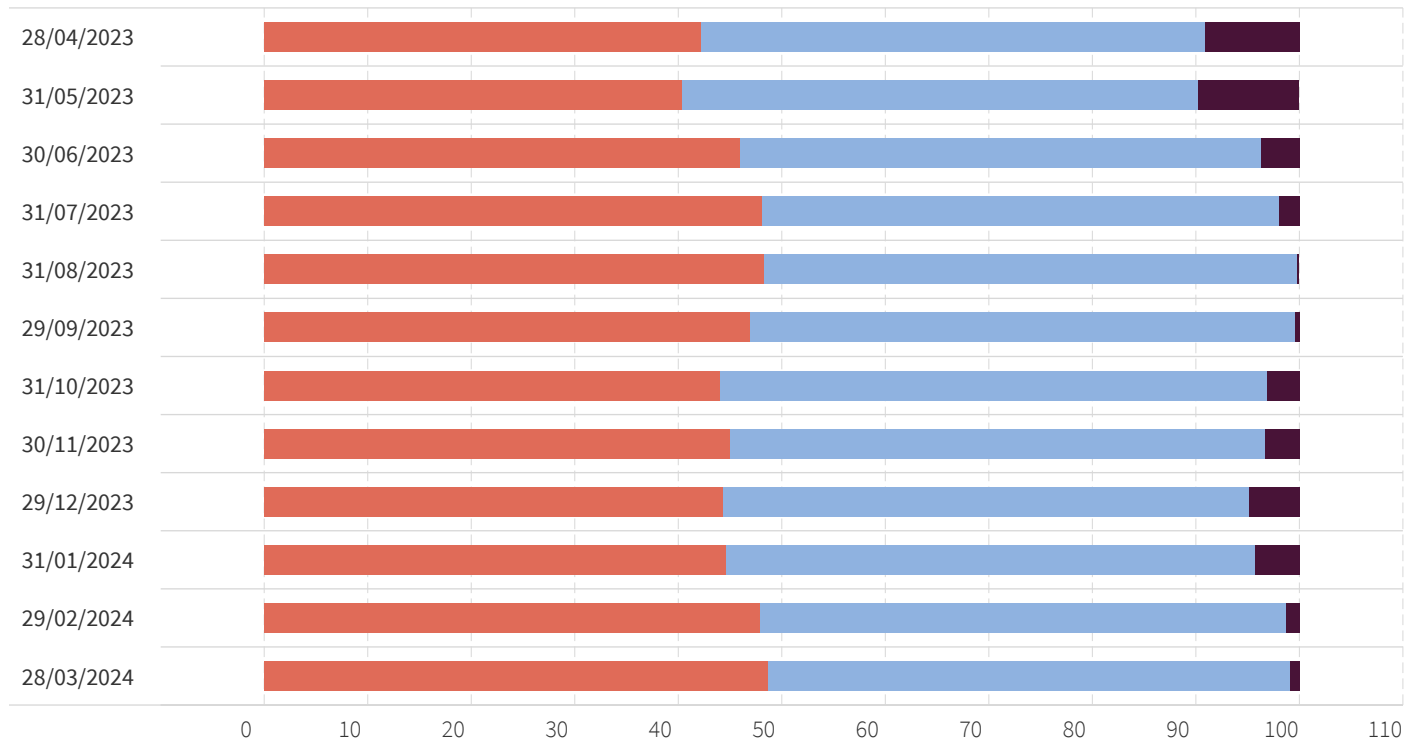

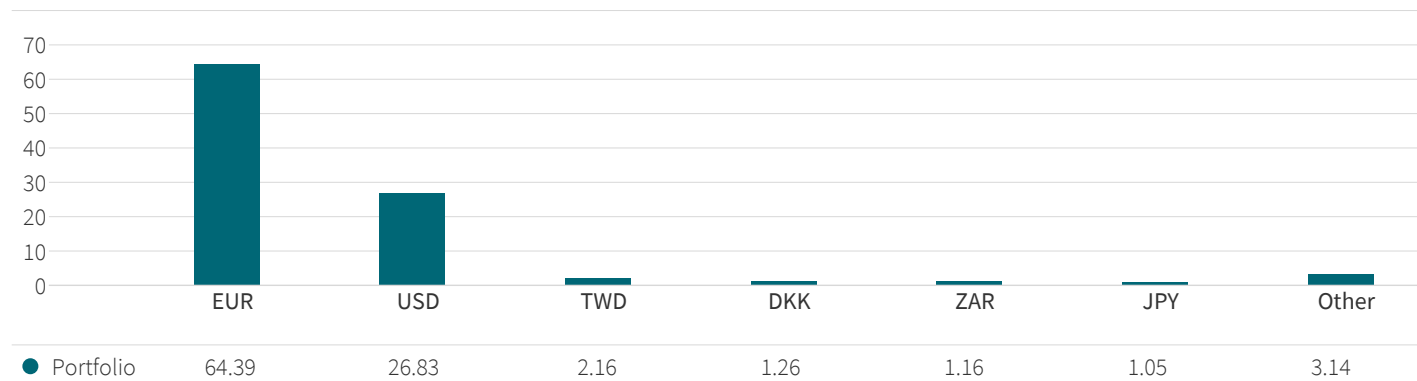

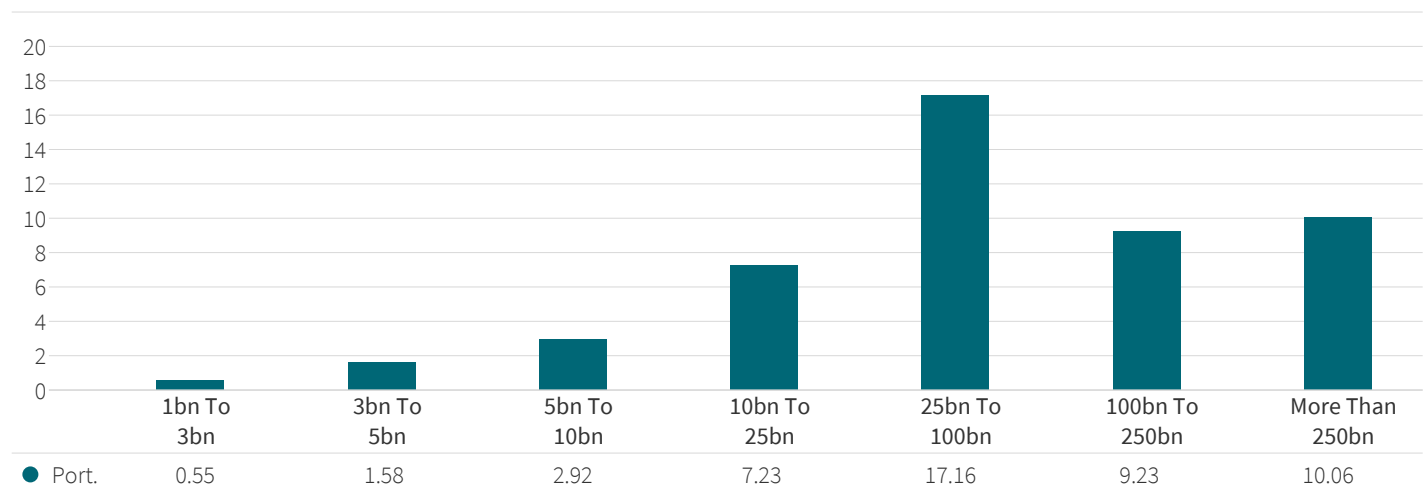

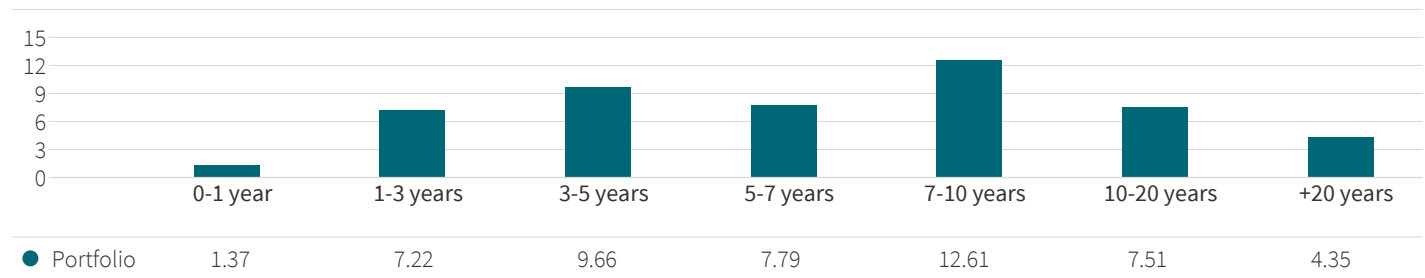

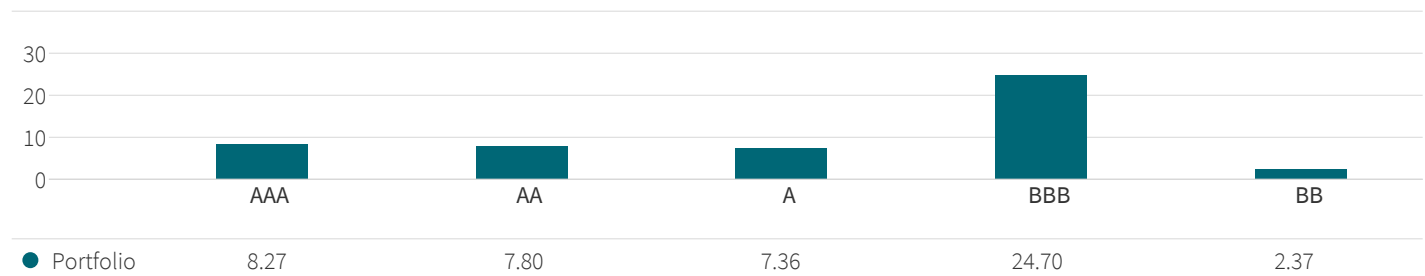

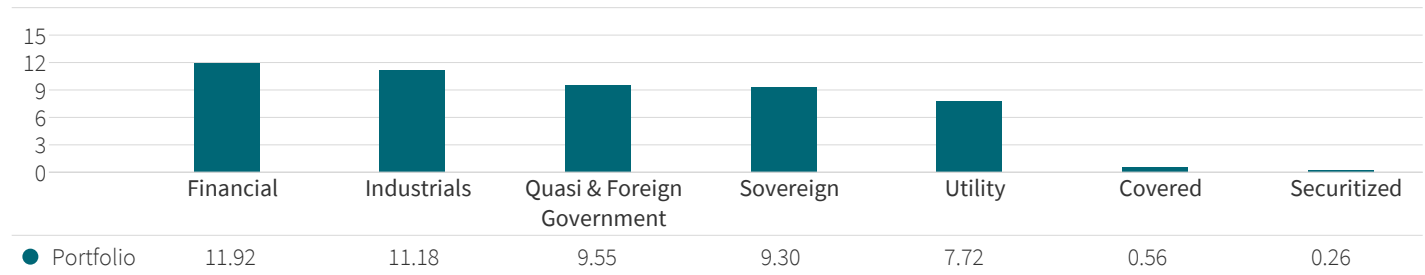
Maturity Breakdown (%)

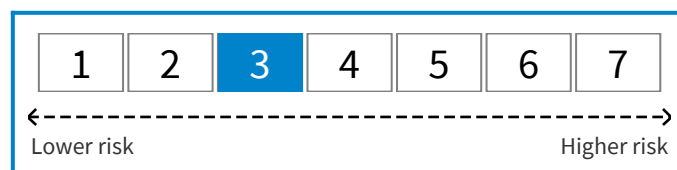
