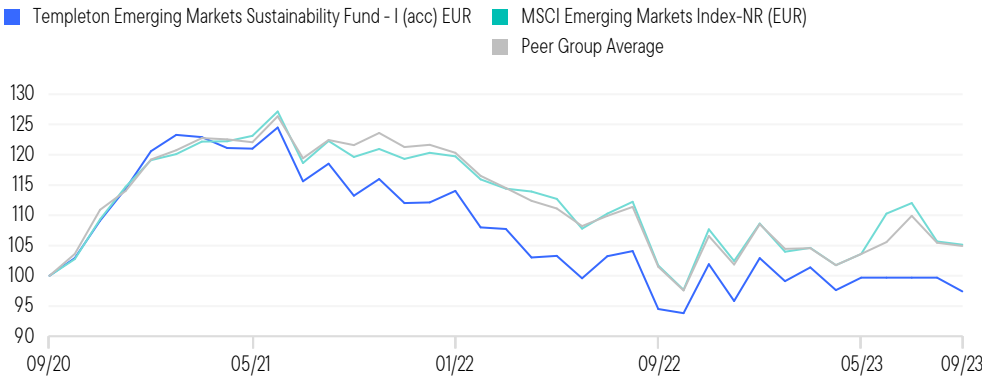

Investment Overview

The Fund is classified as Article 9 under EU Sustainable Finance Disclosure Regulation and aims to increase the value of its investments and reorient capital towards sustainability through investing in companies that demonstrate their positive sustainable contribution over the medium to long term. The Fund pursues an actively managed investment strategy and invests mainly in: equity securities issued by companies located in, having their principal business activities in, or which derive a significant proportion of their revenues or profits from developing or emerging nations.

Glossary

For a portfolio, the value represents a weighted average of the stocks it holds. **Price to Earnings (12-Month Trailing)** is the share price of a stock, divided by its per-share earnings over the past year. For a portfolio, the value represents a weighted average of the stocks it holds. **Price to Cash Flow:** Supplements price/earnings ratio as a measure of relative value for a stock. For a portfolio, the value represents a weighted average of the stocks it holds. **Standard Deviation:** Measure of the degree to which a fund's return varies from the average of its previous returns. The larger the standard deviation, the greater the likelihood (and risk) that a fund's performance will fluctuate from the average return.
