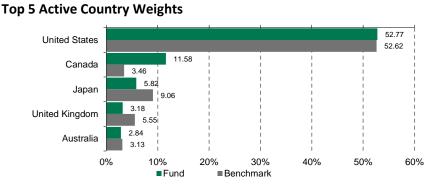

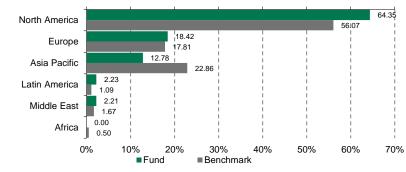

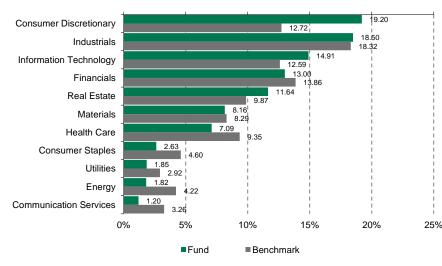
GEOGRAPHIC BREAKDOWN
