Objectives and investment policy

- The objective of the Sub-Fund is to seek medium-term capital appreciation in EUR through a broad range of fixed income investments.
- The Sub-Fund will invest in in fixed income securities, money market instruments (MMI), cash and cash equivalents and actively invest in unconstrained and dynamic asset allocation to seek opportunity in the global changes of interest rates and credit spreads. Notwithstanding the below provisions, the Sub-Fund may temporarily invest exclusively its net assets in cash and cash equivalents, term deposits, debt securities and MMI dealt in on a regulated market.
- More specifically, the fund will invest in corporate and government debt securities and debt-related securities such as bonds, certificates and commercial papers including, but not limited to sovereign government and supranational bonds and emerging markets securities. Such securities will be primarily in OECD countries without any constraint in terms of rating or market capitalization.
- The Sub-Fund may also invest a maximum of 20% in contingent convertibles (also known as CoCo's).
- The Sub-Fund may invest a maximum of 20% in the Chinese bond market by holding securities issued by government or companies domiciled in, or with main activities, within the Peoples Republic of China, Hong Kong and Macao.
- The investment can be done directly or indirectly, through financial derivative instruments or other UCITS/UCIs.
- The Sub-Fund shall not invest more than 10% of its assets in units of UCITS or other UCIs.

- The Sub-Fund will not borrow money to increase its exposure to the markets.
- The Sub-Fund is actively managed without reference to a benchmark.
- The Sub-Fund may use financial derivative instruments for hedging purposes and for investment purposes. The types of derivatives may include, but are not limited to, exchange traded index futures and options, currency futures and forwards and OTC derivatives under ISDA agreement. For protection the Sub-Fund may also hold index or individual CDS up to 30% of its net assets value.
- Unitholders may redeem units on demand, on a daily basis.
- Please note that transaction costs may have material impact on performance.
- Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within 3 years.
- Non-distributing units: any income generated by the Sub-Fund is reinvested.
- This financial product does not promote environmental or social characteristics and does not have as its objective a sustainable objective.
- The investments underlying this financial product do not take into account the EU criteria for environmentally sustainable economic activities.

The Sub-Fund is subject to the following risks:


