It was all the about the Fed this week.

First important element, despite stronger growth and inflation since the beginning of the year, the FOMC left its cutting bias in the statement of its May 1st meeting, implying that the next move should be an adjustment lower in the base rate at some point in the future. Second, as it was expected by many observers, it decided to reduce the pace of its QT programme from \$95 billion a month (60 UST + 35 MBS) to \$60 billion a month (25 UST + 35 MBS), starting in June. The surprise came from the amount of reduction, which was larger than thought. Finally, Chair Powell's press conference at the end of the meeting was more dovish than anticipated. He reiterated that the labour market continued to rebalance and that in his personal opinion, the next move of the Fed will be to cut. He mentioned a new hike as highly improbable. All the above elements reassured rates markets and helped rates rally from this year's high points.

In other news, the unemployment rate in the Eurozone held steady at 6.5% and the April HICP numbers came broadly in line at 2.4% yoy for headline and a little stronger for core at 2.7% yoy. In the US the unit labour cost for Q1 was 4.6% annualized and the ISM manufacturing printed a little below 50.

This week, rates moved lower with US 10yr down 10bps and Germany 10yr down 5bps. Risk assets are down 0,7% for the S&P and 1.8% for the Eurostoxx50. Credit spreads are either flat or tighter for IG and HY. BTP-bund spread is 2bps tighter at 128bps. 10yr breakevens are 5bps lower for the US and 3bps lower for Germany.

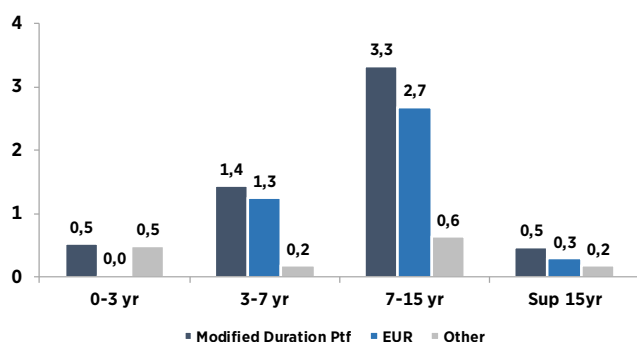

In this context, here are the changes that we have made in EdRF Bond Allocation:

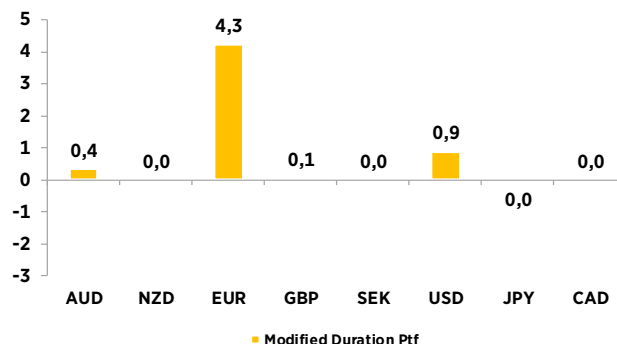
- We increased back some duration towards 6.

Significants Risks
