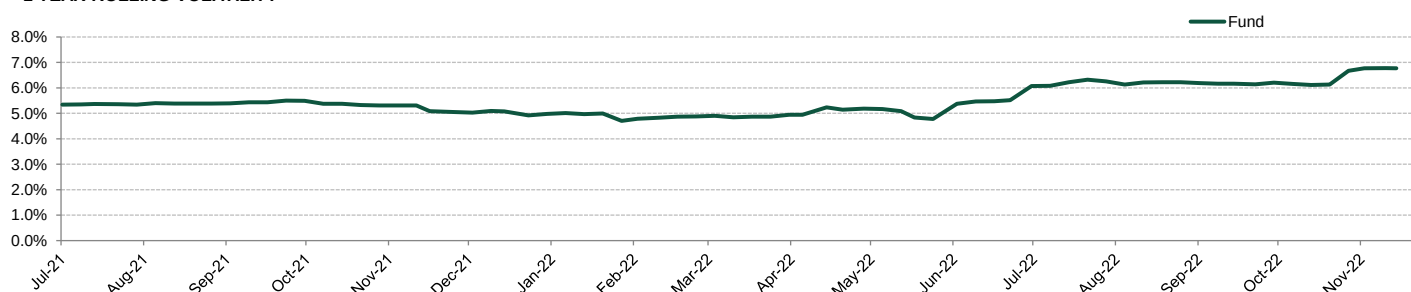
HISTORICAL TRACK RECORD *
